UNIVERSITIES AND UNIVERSITY COLLEGES ACT 1971

CONSTITUTION OF THE UNIVERSITY AGRICULTURE MALAYSIA

AUTHORISATION UNDER SECTION 6

P.U. (A)
409/76.

IN exercise of the powers conferred by subsection (6) of section 6 of the Constitution of the University Agriculture Malaysia, the Council of the University Agriculture Malaysia authorises Dr Ibrahim bin Mohd. Yusof, Acting Director of the University Campus in Sarawak to execute on behalf of the University any document or instrument which is or relates to—

- (i) any purchase agreement for the purposes of the University Campus in Sarawak involving any expenditure up to twenty-five thousand ringgit;
- (ii) a contract of service of a temporary labourer entered into by the University for the purposes of the University service in the University Campus in Sarawak;
- (iii) a service or maintenance agreement in respect of the University equipment in the University Campus in Sarawak; or
- (iv) a scholarship or loan agreement entered into between the University and a student of the University.
