

✓ **P.U. (B) 50.****AKTA CUKAI PENDAPATAN, 1967**

INCOME TAX ACT, 1967

PURSUANT to the provisions of section 127 (2) of the Income Tax Act, 1967, the House of Representatives at its sitting on 18th December, 1975, resolved that Part I of Schedule 6 to the Income Tax Act, 1967 be amended by adding thereto the following new item: *Act 53.*

“29. Notwithstanding the provisions of section 44 (6), the aggregate income of any person remaining after the reductions made pursuant to section 44 (1) (a), (b) and (c) to the extent of the amount of any contribution made by him during the basis period for a year of assessment to the National Monument Restoration Fund established for the purpose of restoring the National Monument in Kuala Lumpur.”

and that the amendment shall have effect for the year of assessment 1976 and subsequent years of assessment.
