An Act to empower racing clubs to promote public sweepstakes.

[1st August 1965.] L.N. 298/65.

BE IT ENACTED by the Duli Yang Maha Mulia Seri Paduka Baginda Yang di-Pertuan Agong with the advice and consent of the Dewan Negara and Dewan Rakyat in Parliament assembled, and by the authority of the same, as follows:

1. (1) This Act may be cited as the Racing Club (Public Sweepstakes) Act 1965.

Short title and application.

(2) This Act shall apply ~~only to the States of West Malaysia.~~

2. (1) A racing club established in the ~~States of West Malaysia~~ may, after the commencement of this Act, promote a sweepstake in which any person (including a person not being a member of the club) may take part; and the Betting Ordinance 1953, shall not apply to any sweepstake so promoted.

(2) In this section the expression "sweepstake" means any sweepstake promoted on the result of a horse race.
