DIPERBUAT oleh Parlimen Malaysia seperti yang berikut:

Tajuk ringkas dan permulaan kuat kuasa

1. (1) Akta ini bolehlah dinamakan Akta Kanun Tatacara Jenayah (Pindaan) 2025.

(2) Akta ini mula berkuat kuasa pada tarikh yang ditetapkan oleh Menteri melalui pemberitahuan dalam *Warta*.

Pindaan Jadual Pertama

2. Kanun Tatacara Jenayah [*Akta 593*] dipinda dalam Jadual Pertama dengan memasukkan selepas butiran yang berhubungan dengan seksyen 507^A Kanun Keseksaan [*Akta 574*] dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:
