## SUPPLY ACT 2015

An Act to apply a sum from the Consolidated Fund for the service of the year 2015 and to appropriate that sum for the service of that year.

[ ]

**ENACTED** by the Parliament of Malaysia as follows:

### **Short title**

1. This Act may be cited as the Supply Act 2015.

### **Issue and appropriation for the service of the year 2015**

2. The issue of a sum not exceeding one hundred and seventy-six billion nine hundred and thirty-one million seven hundred and thirty-one thousand ringgit (RM176,931,731,000) from the Consolidated Fund for the service of the year 2015 is hereby authorised and that sum is appropriated for the purposes specified in the Schedule.
