ACT 2011**

An Act to amend the Judges' Remuneration Act 1971.

ENACTED by the Parliament of Malaysia as follows:

Short title and commencement

1. (1) This Act may be cited as the Judges' Remuneration (Amendment) (No. 2) Act 2011.

(2) This Act comes into operation on 1 January 2012.

Amendment of section 11

2. The Judges' Remuneration Act 1971 [*Act 45*], which is referred to as the "principal Act" in this Act, is amended in section 11 by substituting for the words "twelve and a half years", wherever they appear, the words "twenty years".

Savings and transitional

3. The payment of derivative pension in consequence of the amendment made under section 2 of this Act to persons other than those mentioned in subsection 11(3) of the principal Act, if the period of twelve and a half years has expired before 1 January 2012, shall be dealt with as follows:

- (a) the period of twenty years shall be calculated from the date of the retirement of the Judge;
- (b) the persons shall not be entitled to the payment of derivative pension for the period after the expiration of the period of twelve and a half years until 31 December 2011; and
- (c) the payment of derivative pension shall only be made from 1 January 2012.
