AKTA IMIGRESEN 1959/63 DAN AKTA PASPORT 1966

PERINTAH IMIGRESEN DAN PASPORT (PENGECUALIAN) 2026

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Imigresen 1959/63 [Akta 155] dan seksyen 4 Akta Pasport 1966 [Akta 150], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Imigresen dan Pasport (Pengecualian) 2026**.

(2) Perintah ini berkuat kuasa mulai 1 Jun 2026 hingga 17 Oktober 2029.

Pengecualian

2. Menteri mengecualikan mana-mana orang yang memasuki Malaysia melalui laut melalui L04B Pos Kawalan Imigresen, Pelabuhan Tanjung Malai, Langkawi, Kedah, L06 Pulau Pinang, L08 Pelabuhan Kelang, L09 Pelabuhan Melaka, L28 Dermaga Pending, Kuching, Bahagian Pertama atau L51 Dermaga Kota Kinabalu daripada pemakaian subseksyen 24(1) Akta Imigresen 1959/63, seksyen 2 Akta Pasport 1966 dan peraturan 15 Peraturan-Peraturan Imigresen, 1963 [L.N. 228/63].

IMMIGRATION ACT 1959/63 AND PASSPORTS ACT 1966
IMMIGRATION AND PASSPORTS (EXEMPTION) ORDER 2026

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [Act 155] and section 4 of the Passports Act 1966 [Act 150], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Immigration and Passports (Exemption) Order 2026**.

(2) This Order has effect from 1 June 2026 to 17 October 2029.

Exemption

2. The Minister exempts any person entering Malaysia by sea by L04B Immigration Control Post, Tanjung Malai Port, Langkawi, Kedah, L06 Pulau Pinang, L08 Pelabuhan Kelang, L09 Malacca Port, L28 Pending Wharf, Kuching, 1st Division or L51 Kota Kinabalu Wharf from the application of subsection 24(1) of the Immigration Act 1959/63, section 2 of the Passports Act 1966 and regulation 15 of the Immigration Regulations, 1963 [L.N. 228/63].
