PERINTAH DUTI EKSAIS (PENGECUALIAN) (PINDAAN) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 11(1) Akta Eksais 1976 [Akta 176], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Eksais (Pengecualian) (Pindaan) 2026**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2026.

Pindaan Jadual

2. Perintah Duti Eksais (Pengecualian) 2017 [P.U. (A) 444/2017] dipinda dalam Jadual, dalam Bahagian I, berhubung dengan butiran 33—

(a) dalam ruang (2), dengan menggantikan perkataan “Air Asia X Sdn. Bhd.” dengan perkataan “AirAsia X Berhad”; dan

(b) dalam ruang (4), dengan menggantikan subbutiran (a) dengan subbutiran yang berikut:

“(a) That the goods are imported or purchased from a licensed manufacturer and are solely to be used or for sale by and in the aircraft of AirAsia X Berhad in its international flights;”.

EXCISE ACT 1976

EXCISE DUTIES (EXEMPTION) (AMENDMENT) ORDER 2026

IN exercise of the powers conferred by subsection 11(1) of the Excise Act 1976 [Act 176], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Excise Duties (Exemption) (Amendment) Order 2026**.

(2) This Order comes into operation on 1 June 2026.

Amendment of Schedule

2. The Excise Duties (Exemption) Order 2017 [P.U. (A) 444/2017] is amended in the Schedule, in Part I, in relation to item 33—

(a) in column (2), by substituting for the words “Air Asia X Sdn. Bhd.” the words “AirAsia X Berhad”; and

(b) in column (4), by substituting for subitem (a) the following subitem:

“(a) That the goods are imported or purchased from a licensed manufacturer and are solely to be used or for sale by and in the aircraft of AirAsia X Berhad in its international flights;”.
