(A) 58/1989*] mulai 19 April 2024.

HOUSING DEVELOPMENT (CONTROL AND LICENSING) ACT 1966

HOUSING DEVELOPMENT (CONTROL AND LICENSING) (EXEMPTION) ORDER 2026

IN exercise of the powers conferred by subsection 2(2) of the Housing Development (Control and Licensing) Act 1966 [*Act 118*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Housing Development (Control and Licensing) (Exemption) Order 2026**.

**Exemption**

2. The Minister exempts Country View Resources Sdn. Bhd. (Housing Developer's Licence Number: 8428/12-2026/1466(A)) from the application of provision of advertisement and sale permit as prescribed in regulation 5 of the Housing Development (Control and Licensing) Regulations 1989 [*P.U. (A) 58/1989*] from 19 April 2024.
