AKTA IMIGRESEN 1959/63

PERINTAH IMIGRESEN (PENGECUALIAN) (NO. 11) 2026

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Imigresen 1959/63 [Akta 155], Menteri membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Imigresen (Pengecualian) (No. 11) 2026**.

Pengecualian

2. Menteri mengecualikan mana-mana warganegara Brunei Darussalam yang berdaftar di bawah *Brunei-Malaysia Frequent Traveller Programme* daripada pemakaian perenggan 6(1)(c) Akta bagi kemasukan ke dalam Malaysia pada kali kedua dan seterusnya.

Syarat pengecualian

3. Mana-mana warganegara Brunei Darussalam yang dikecualikan di bawah perenggan 2 adalah tertakluk kepada syarat yang berikut:

- (a) memiliki Pas yang sah yang dikeluarkan bagi kemasukan kali pertama ke dalam Malaysia;
- (b) kemasukan ke dalam Malaysia hendaklah melalui D20 Sungai Tujoh, D22A Pos Kawalan Imigresen Tedungan Daerah Batu Danau Limbang, Bahagian Kelima di dalam Negeri Sarawak, D22B Pos Kawalan Imigresen di Pandaruan, Limbang atau D22C Pos Kawalan Imigresen di Mengkalap, Daerah Lawas di dalam Negeri Sarawak; dan
- (c) kemasukan ke dalam Malaysia pada kali kedua dan seterusnya adalah dalam tempoh sembilan puluh hari dari tarikh pengeluaran Pas di bawah subperenggan 3(a).

IMMIGRATION ACT 1959/63

IMMIGRATION (EXEMPTION) (NO. 11) ORDER 2026

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [Act 155], the Minister makes the following order:

Citation

1. This order may be cited as the **Immigration (Exemption) (No. 11) Order 2026**.

Exemption

2. The Minister exempts any citizen of Brunei Darussalam registered under the Brunei-Malaysia Frequent Traveller Programme from the application of paragraph 6(1)(c) of the Act for the entry into Malaysia for the second time and onwards.

Conditions of exemption

3. Any citizen of Brunei Darussalam who is exempted under paragraph 2 is subject to the following conditions:

- (a) possess a valid Pass issued for the first time entry into Malaysia;
- (b) entry into Malaysia shall be through D20 Sungai Tujoh, D22A Immigration Control Post at Tedungan in the District of Batu Danau Limbang, Fifth Division in the State of Sarawak, D22B Immigration Control Post at Pandaruan, Limbang or D22C Immigration Control Post at Mengkalap, Lawas District in the State of Sarawak; and
- (c) entry into Malaysia for the second time and onwards is within the period of ninety days from the date of the issuance of the Pass under subparagraph 3(a).
