AKTA PEMBANGUNAN KEMAHIRAN KEBANGSAAN 2006

PERATURAN-PERATURAN PEMBANGUNAN KEMAHIRAN KEBANGSAAN
(PENEPIAN FI KEPADA PELATIH DI PUSAT LATIHAN GURNEY, KUALA LUMPUR) 2026

PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Pelatih di Pusat Latihan Gurney, Kuala Lumpur) 2026**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Julai 2025.

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam subsubbutiran 1(a)(i) Jadual Kedua kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2016 [*P.U. (A) 86/2016*] diketepikan berkenaan dengan seseorang pelatih warganegara yang memohon bagi pengiktirafan kemahiran yang membawa kepada penganugerahan Sijil Kemahiran Malaysia melalui Pusat Latihan Gurney, Kuala Lumpur.

(2) Penepian fi di bawah subperaturan (1) adalah terpakai bagi permohonan pengiktirafan kemahiran yang dibuat dalam tempoh tiga tahun mulai 1 Julai 2025 hingga 30 Jun 2028.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT (WAIVER OF FEE TO TRAINEE
AT PUSAT LATIHAN GURNEY, KUALA LUMPUR) REGULATIONS 2026

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Trainee at Pusat Latihan Gurney, Kuala Lumpur) Regulations 2026**.

(2) These Regulations are deemed to have come into operation on 1 July 2025.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in subsubitem 1(a)(i) of the Second Schedule to the National Skills Development (Fees and Charges) Regulations 2016 [P.U. (A) 86/2016] is waived in respect of a citizen trainee who applies for recognition of skills leading to the award of the Malaysian Skills Certificate through Pusat Latihan Gurney, Kuala Lumpur.

(2) The waiver of fee under subregulation (1) is applicable to application for recognition of skills made within the period of three years from 1 July 2025 to 30 June 2028.
