PERINTAH IMIGRESEN (PENGECUALIAN) (NO. 6) 2026

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Imigresen 1959/63 [Akta 155], Menteri membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Imigresen (Pengecualian) (No. 6) 2026**.

Pengecualian

2. Menteri mengecualikan mana-mana orang yang memasuki Malaysia melalui darat melalui jalan dari Kuala Lurah, Brunei Darussalam dan berada di jalan ini hingga tiba di Pos Kawalan Imigresen Tedungan Daerah Batu Danau Limbang, Bahagian Kelima di dalam Negeri Sarawak daripada pemakaian peraturan 36 Peraturan-Peraturan Imigresen, 1963 [L.N. 228/63].

IMMIGRATION ACT 1959/63

IMMIGRATION (EXEMPTION) (NO. 6) ORDER 2026

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [Act 155], the Minister makes the following order:

Citation

1. This order may be cited as the **Immigration (Exemption) (No. 6) Order 2026**.

Exemption

2. The Minister exempts any person entering Malaysia by land by road from Kuala Lurah, Brunei Darussalam and remaining on this road till arrival at the Immigration Control Post Tedungan in the District of Batu Danau Limbang, Fifth Division in the State of Sarawak from the application of regulation 36 of the Immigration Regulations, 1963 [L.N. 228/63].
