PERATURAN-PERATURAN KAWALAN BEKALAN (LARANGAN PENJUALAN DAN PEMBELIAN BARANG KAWALAN) (MINYAK MASAK) 2026

PADA menjalankan kuasa yang diberikan oleh perenggan 6(2)(a) Akta Kawalan Bekalan 1961 [*Akta 122*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kawalan Bekalan (Larangan Penjualan dan Pembelian Barang Kawalan) (Minyak Masak) 2026**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Mac 2026.

Larangan penjualan

2. (1) Tiada seorang pun boleh menjual minyak masak dalam bungkusan polibeg (1 kilogram) kepada orang yang bukan warganegara.

(2) Mana-mana orang yang melanggar subperaturan (1) melakukan suatu kesalahan.

Larangan pembelian

3. (1) Tiada seorang pun yang bukan warganegara boleh membeli minyak masak dalam bungkusan polibeg (1 kilogram).

(2) Mana-mana orang yang melanggar subperaturan (1) melakukan suatu kesalahan.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (PROHIBITION ON SALE AND PURCHASE OF CONTROLLED
ARTICLE) (COOKING OIL) REGULATIONS 2026

IN exercise of the powers conferred by paragraph 6(2)(a) of the Control of Supplies Act 1961 [Act 122], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Control of Supplies (Prohibition on Sale and Purchase of Controlled Article) (Cooking Oil) Regulations 2026**.

(2) These Regulations come into operation on 1 March 2026.

Prohibition on sale

2. (1) No person shall sell cooking oil in polybag packaging (1 kilogram) to person who is not a citizen.

(2) Any person who contravenes subregulation (1) commits an offence.

Prohibition on purchase

3. (1) No person who is not a citizen shall purchase cooking oil in polybag packaging (1 kilogram).

(2) Any person who contravenes subregulation (1) commits an offence.
