AKTA AGENSI PELAPORAN KREDIT 2010

PERINTAH AGENSI PELAPORAN KREDIT  
(AMAUN MINIMUM MODAL BERBAYAR) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 20(1) Akta Agensi Pelaporan Kredit 2010 [*Akta 710*], Menteri, atas syor Pendaftar, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Agensi Pelaporan Kredit (Amaun Minimum Modal Berbayar) 2026**.

(2) Perintah ini mula berkuat kuasa pada 1 Mac 2026.

**Amaun minimum modal berbayar**

2. Amaun minimum modal berbayar sesuatu agensi pelaporan kredit ialah lima juta ringgit.

**Peralihan**

3. Mana-mana agensi pelaporan kredit yang modal berbayarnya kurang daripada amaun minimum sebagaimana yang dinyatakan dalam perenggan 2 sebelum tarikh kuat kuasa Perintah ini hendaklah, tidak lewat daripada 1 Januari 2029, menyenggara dan menaikkan modal berbayarnya supaya mematuhi amaun minimum itu.

CREDIT REPORTING AGENCIES ACT 2010

CREDIT REPORTING AGENCIES  
(MINIMUM AMOUNT OF PAID-UP CAPITAL) ORDER 2026

IN exercise of the powers conferred by subsection 20(1) of the Credit Reporting Agencies Act 2010 [*Act 710*], the Minister, on the recommendation of the Registrar, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Credit Reporting Agencies (Minimum Amount of Paid-Up Capital) Order 2026**.

(2) This Order comes into operation on 1 March 2026.

**Minimum amount of paid-up capital**

2. The minimum amount of paid-up capital of a credit reporting agency shall be five million ringgit.

**Transitional**

3. Any credit reporting agency whose paid-up capital is less than the minimum amount as specified in paragraph 2 before the date of the coming into operation of this Order shall, not later than 1 January 2029, maintain and increase its paid-up capital to comply with the minimum amount.
