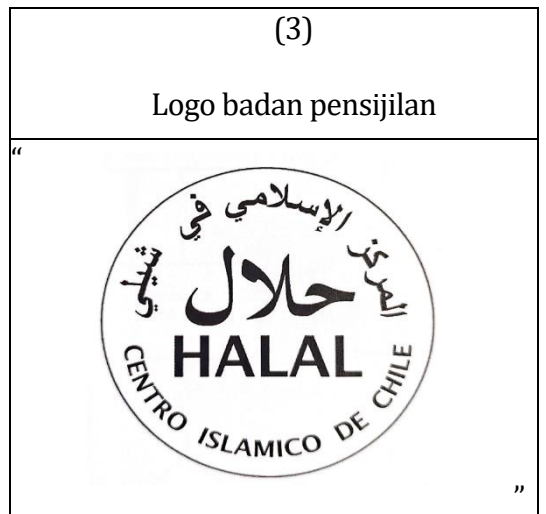

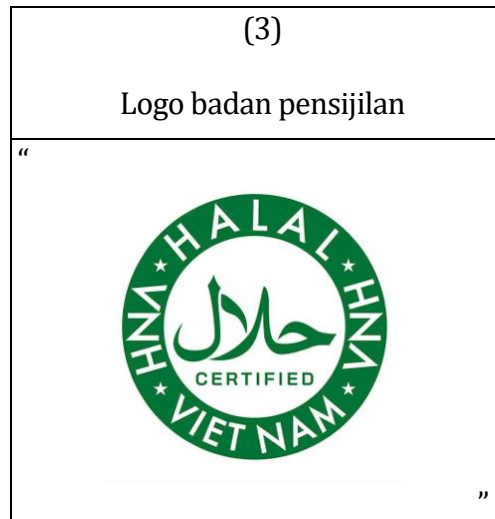

TRADE DESCRIPTIONS ACT 2011

TRADE DESCRIPTIONS (CERTIFICATION AND MARKING OF HALAL)
(AMENDMENT) ORDER 2026

IN exercise of the powers conferred by section 29 of the Trade Descriptions Act 2011 [Act 730], the Minister makes the following order:

Citation and commencement


1. (1) This order may be cited as the **Trade Descriptions (Certification and Marking of Halal) (Amendment) Order 2026**.

(2) This Order comes into operation on 30 January 2026.

Amendment of Second Schedule


2. The Trade Descriptions (Certification and Marking of Halal) Order 2011 [P.U. (A) 431/2011] is amended in the Second Schedule—

(a) in item China, by inserting after the name of certification body “Halal Certification Services Chongqing (HCS)” in column (2) and the logo of certification body appearing against it in column (3) the following particulars:

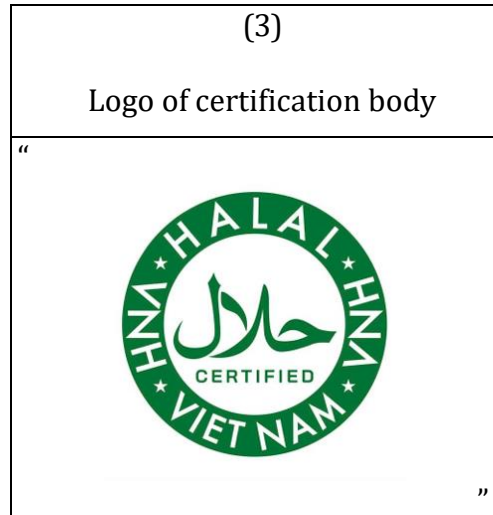
