**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pusat Timbang Tara Antarabangsa Asia (Malaysia) (Keistimewaan dan Kekebalan) (Pindaan) 2026**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Januari 2026.

ASIAN INTERNATIONAL ARBITRATION CENTRE (MALAYSIA)  
(PRIVILEGES AND IMMUNITIES) (AMENDMENT) REGULATIONS 2026

IN exercise of the powers conferred by subsections 3(1) and 4(1) of the International Organizations (Privileges and Immunities) Act 1992 [*Act 485*], the Minister, with the concurrence of the Minister of Finance, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Asian International Arbitration Centre (Malaysia) (Privileges and Immunities) (Amendment) Regulations 2026**.

(2) These Regulations is deemed to have come into operation on 1 January 2026.

**Amendment of regulation 1A**

2. Regulation 1A of the Asian International Arbitration Centre (Malaysia) (Privileges and Immunities) Regulations 1996 [*P.U. (A) 120/1996*] is amended in the definition of “High Officer” by substituting for the words “Director of the Kuala Lumpur Regional Centre for Arbitration” the words “President of the Asian International Arbitration Centre Court of Arbitration”.
