PERATURAN-PERATURAN PASARAN MODAL DAN PERKHIDMATAN (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 378(1) Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pasaran Modal dan Perkhidmatan (Pindaan) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2026.

CAPITAL MARKETS AND SERVICES ACT 2007

CAPITAL MARKETS AND SERVICES (AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by subsection 378(1) of the Capital Markets and Services Act 2007 [Act 671], the Commission, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Capital Markets and Services (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 1 January 2026.

Deletion of regulation 8

2. The Capital Markets and Services Regulations 2012 [*P.U. (A) 474/2012*], which are referred to as the “principal Regulations” in these Regulations, are amended by deleting regulation 8.

Deletion of Schedule 2, Schedule 3 and Schedule 4

3. The principal Regulations are amended by deleting Schedule 2, Schedule 3 and Schedule 4.
