AKTA SARAAN HAKIM 1971

PERATURAN-PERATURAN SARAAN HAKIM
(PINDAAN JADUAL PERTAMA DAN KELIMA) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 19 Akta Saraan Hakim 1971 [Akta 45], Yang di-Pertuan Agong, selepas berunding dengan Ketua Hakim Negara, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Saraan Hakim (Pindaan Jadual Pertama dan Kelima) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2026.

Pindaan Jadual Pertama

2. Akta Saraan Hakim 1971, yang disebut “Akta ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan Jadual Pertama dengan jadual yang berikut:

JUDGES' REMUNERATION ACT 1971

JUDGES' REMUNERATION (AMENDMENT OF FIRST AND FIFTH SCHEDULES)
REGULATIONS 2025

IN exercise of the powers conferred by section 19 of the Judges' Remuneration Act 1971 [Act 45], the Yang di-Pertuan Agong, after consultation with the Chief Justice, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Judges' Remuneration (Amendment of First and Fifth Schedules) Regulations 2025**.

(2) These Regulations come into operation on 1 January 2026.

Amendment of First Schedule

2. The Judges' Remuneration Act 1971, which is referred to as the "principal Act" in these Regulations, is amended by substituting for the First Schedule the following schedule:

Amendment of Fifth Schedule

3. The Fifth Schedule to the principal Act is amended in paragraph 1, by substituting for the words "RM25,500.00" the words "RM33,150.00".
