PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 5) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 5) 2025**.

(2) Perintah ini mula berkuat kuasa pada 14 November 2025.

Pindaan Jadual

2. Perintah Duti Kastam (Pengecualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Jadual, dalam Bahagian I, berhubung dengan butiran 67, dalam ruang (2)—

(a) dalam subbutiran (xi), dengan menggantikan perkataan “SapuraOMV Upstream (Sarawak) Inc.” dengan perkataan “TotalEnergies EP Sarawak Inc. (formerly known as SapuraOMV Upstream (Sarawak) Inc.)”;

(b) dalam subbutiran (xiii), dengan menggantikan perkataan “Kebabangan Petroleum Operating Company Sdn Bhd.” dengan perkataan “ConocoPhillips Sabah Gas Ltd. (formerly known as Kebabangan Petroleum Operating Company Sdn Bhd.)”;

(c) dalam subbutiran (xxxii), dengan memasukkan koma bernoktah di hujung subbutiran itu; dan

(d) dengan memasukkan selepas subbutiran (xxxii) subbutiran yang berikut:

“(xxxiii) SK Earthon Co. Ltd.”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 5) ORDER 2025

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 5) Order 2025**.

(2) This Order comes into operation on 14 November 2025.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [*P.U. (A) 445/2017*] is amended in the Schedule, in Part I, in relation to item 67, in column (2)—

(a) in subitem (xi), by substituting for the words “SapuraOMV Upstream (Sarawak) Inc.” the words “TotalEnergies EP Sarawak Inc. (formerly known as SapuraOMV Upstream (Sarawak) Inc.)”;

(b) in subitem (xiii), by substituting for the words “Kebabangan Petroleum Operating Company Sdn Bhd.” the words “ConocoPhillips Sabah Gas Ltd. (formerly known as Kebabangan Petroleum Operating Company Sdn Bhd.)”;

(c) in subitem (xxxii), by inserting a semicolon at the end of the subitem; and

(d) by inserting after subitem (xxxii) the following subitem:

“(xxxiii) SK Earthon Co. Ltd.”.
