PADA menjalankan kuasa yang diberikan oleh subseksyen 92(1) Akta Institusi Pendidikan Tinggi Swasta 1996 [*Akta 555*], Menteri membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Institusi Pendidikan Tinggi Swasta (Pengeccualian kepada Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College)) 2025**.

Pengeccualian

2. (1) Tertakluk kepada subperenggan (2) Menteri mengeccualikan Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College) (Nombor Perakuan Pendaftaran: DK044(B)) daripada pemakaian subseksyen 24A(3) Akta berhubung dengan permohonan bagi pembaharuan pendaftarannya sebagai suatu institusi pendidikan tinggi swasta yang telah habis tempoh pada 16 Mei 2022.

(2) Pengeccualian di bawah subperenggan (1) adalah tertakluk kepada syarat bahawa Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College) mengemukakan permohonan bagi pembaharuan pendaftaran dalam tempoh tiga bulan daripada tarikh permulaan kuat kuasa Perintah ini.

PRIVATE HIGHER EDUCATIONAL INSTITUTIONS
(EXEMPTION TO KOLEJ PERNIAGAAN BERSEPADU MALAYSIA
(MALAYSIAN INTEGRATED BUSINESS COLLEGE)) ORDER 2025

IN exercise of the powers conferred by subsection 92(1) of the Private Higher Educational Institutions Act 1996 [*Act 555*], the Minister makes the following order:

Citation

1. This order may be cited as the **Private Higher Educational Institutions (Exemption to Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College)) Order 2025**.

Exemption

2. (1) Subject to subparagraph (2) the Minister exempts Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College) (Certificate of Registration Number: DK044(B)) from the application of subsection 24A(3) of the Act in relation to the application for renewal of its registration as a private higher educational institution which has expired on 16 May 2022.

(2) The exemption under subparagraph (1) is subject to the condition that Kolej Perniagaan Bersepadu Malaysia (Malaysian Integrated Business College) submits the application for renewal of registration within three months from the date of commencement of this Order.
