INTERNATIONAL ORGANIZATIONS (PRIVILEGES AND IMMUNITIES) (ASEAN)
(AMENDMENT OF SCHEDULE) REGULATIONS 2025

IN exercise of the powers conferred by subsections 3(1) and 4(1) and section 11 of the International Organizations (Privileges and Immunities) Act 1992 [*Act 485*], the Minister, with the concurrence of the Minister of Finance, makes the following regulations:

Citation

1. These regulations may be cited as the **International Organizations (Privileges and Immunities) (ASEAN) (Amendment of Schedule) Regulations 2025**.

Amendment of Schedule

2. The Schedule to the International Organizations (Privileges and Immunities) (ASEAN) Regulations 2017 [*P.U. (A) 38/2017*] is amended by inserting after item 4(b)(xiv) the following item:

“(xv) ASEAN Coordinating Centre for Animal Health and Zoonoses (ACCAHZ)”.
