AKTA IMIGRESEN 1959/63

PERINTAH IMIGRESEN (PENGECUALIAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Imigresen 1959/63 [Akta 155], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Imigresen (Pengecualian) 2025**.

(2) Perintah ini mula berkuat kuasa pada 22 September 2025.

Pengecualian

2. Menteri mengecualikan pemakaian peraturan 36 Peraturan-Peraturan Imigresen, 1963 [L.N. 228/63] bagi mana-mana orang yang memasuki Malaysia dengan jalan darat melalui Jalan Sadao-Padang Besar, Thailand dan Jalan FT251, Mukim Titi Tinggi, Negeri Perlis, Malaysia.

IMMIGRATION ACT 1959/63

IMMIGRATION (EXEMPTION) ORDER 2025

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [Act 155], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Immigration (Exemption) Order 2025**.
- (2) This Order comes into operation on 22 September 2025.

Exemption

2. The Minister exempts the application of regulation 36 of the Immigration Regulations, 1963 [L.N. 228/63] to any person entering Malaysia by land *via* Jalan Sadao-Padang Besar, Thailand and Jalan FT251, Mukim Titi Tinggi, State of Perlis, Malaysia.
