ENTERTAINMENTS DUTY (EXEMPTION) (NO. 27) ORDER 2025

IN exercise of the powers conferred by paragraph 12(1)(b) of the Entertainments Duty Act 1953 [*Act 103*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Entertainments Duty (Exemption) (No. 27) Order 2025**.

**Exemption**

2. The Minister exempts the admission ticket for the G-DRAGON 2025 World Tour [Übermensch] IN KUALA LUMPUR show which was held at Bukit Jalil Axiata Arena, Kuala Lumpur on 19 July 2025 and 20 July 2025 from entertainments duty.
