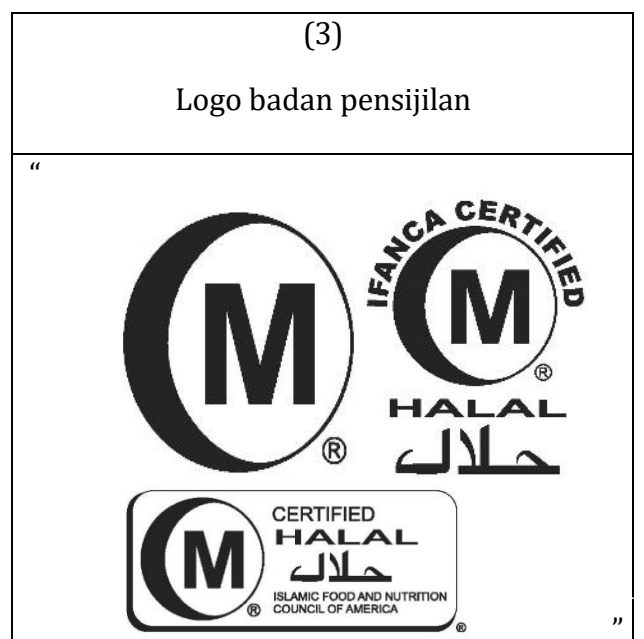

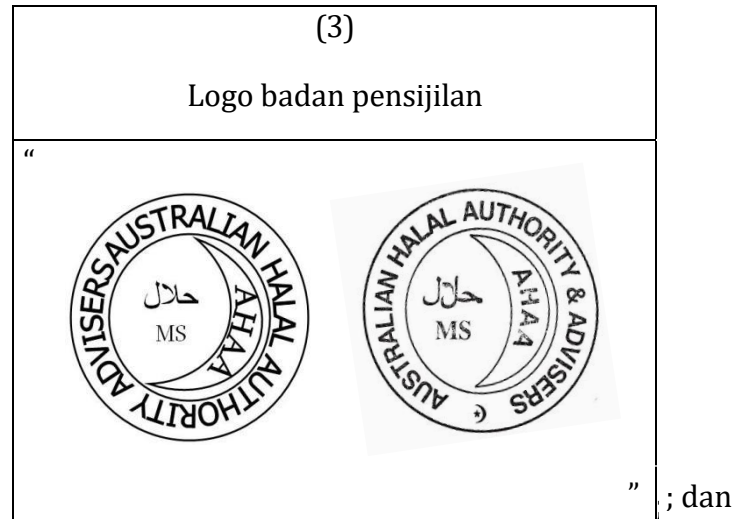

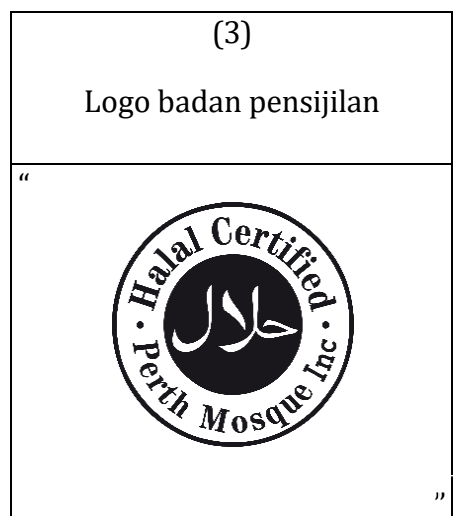

Citation and commencement

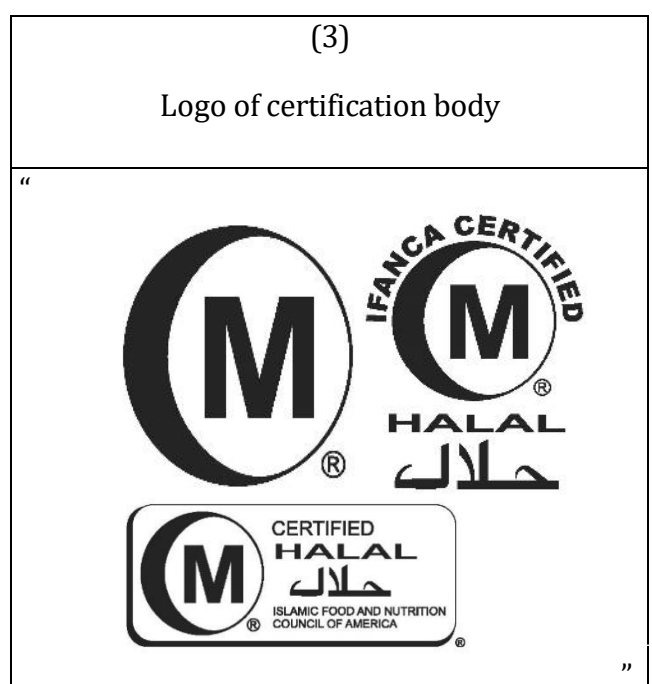
1. (1) This order may be cited as the **Trade Descriptions (Certification and Marking of Halal) (Amendment) (No. 2) Order 2025**.

(2) This Order comes into operation on 29 August 2025.

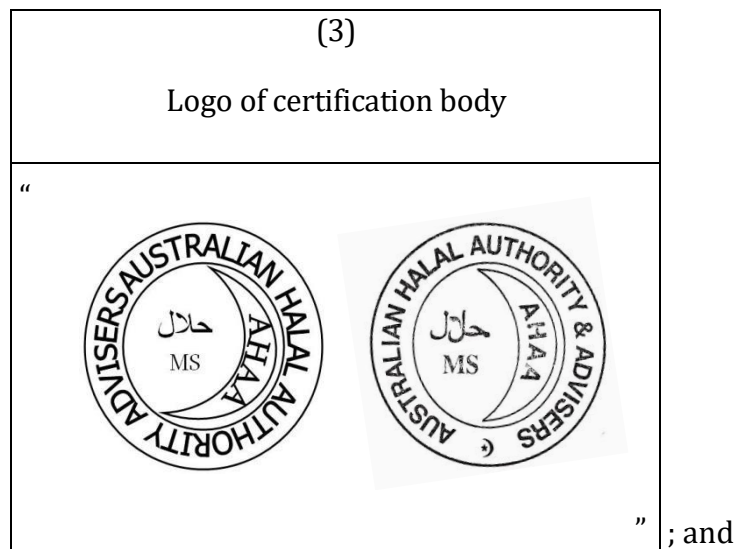
2. The Trade Descriptions (Certification and Marking of Halal) Order 2011 [P.U. (A) 431/2011] is amended in the Second Schedule—

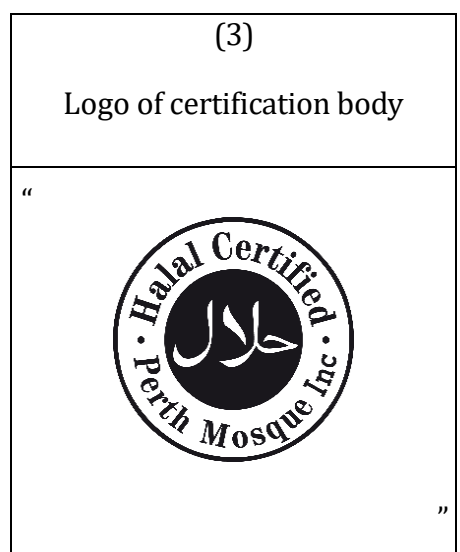
