PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 3) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 3) 2025**.

(2) Perintah ini mula berkuat kuasa pada 20 Ogos 2025.

(A) 445/2017*] dipinda dalam Jadual, dalam Bahagian I, berhubung dengan butiran 67, dalam ruang (2), dalam subbutiran (v), dengan menggantikan perkataan “JX Nippon Oil & Gas Exploration (Malaysia) Limited” dengan perkataan “ENEOS Xplora Malaysia Limited (formerly known as JX Nippon Oil & Gas Exploration (Malaysia) Limited)”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 3) ORDER 2025

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 3) Order 2025**.

(2) This Order comes into operation on 20 August 2025.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in the Schedule, in Part I, in relation to item 67, in column (2), in subitem (v), by substituting for the words “JX Nippon Oil & Gas Exploration (Malaysia) Limited” the words “ENEOS Xplora Malaysia Limited (formerly known as JX Nippon Oil & Gas Exploration (Malaysia) Limited)”.
