PERATURAN-PERATURAN INDUSTRI PERKHIDMATAN AIR  
(KADAR PERKHIDMATAN BEKALAN AIR) (NEGERI MELAKA) (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh perenggan 84(2)(a) dan 179(i) Akta Industri Perkhidmatan Air 2006 [*Akta 655*], Menteri, atas syor Suruhanjaya, membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Industri Perkhidmatan Air (Kadar Perkhidmatan Bekalan Air) (Negeri Melaka) (Pindaan) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Ogos 2025.

WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (RATES FOR WATER SUPPLY SERVICES)  
(STATE OF MALACCA) (AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by paragraphs 84(2)(a) and 179(i) of the Water Services Industry Act 2006 [Act 655], the Minister, on the recommendation of the Commission, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Water Services Industry (Rates for Water Supply Services) (State of Malacca) (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 1 August 2025.

**Substitution of First Schedule**

2. The Water Services Industry (Rates for Water Supply Services) (State of Malacca) Regulations 2010 [*P.U. (A) 372/2010*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for the First Schedule the following schedule:
