AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SKIM FELDA) (PINDAAN) (NO. 2) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Perlis, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Skim Felda) (Pindaan) (No. 2) 2025**.

(2) Perintah ini mula berkuat kuasa pada 30 Jun 2025.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Skim Felda) 1991 [P.U. (A) 449/1991], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala Negeri Perlis—

(a) berhubung dengan butiran Mata Air—

(i) dalam ruang *Jalan Masuk (km)*, dengan menggantikan perkataan “2.750” dengan perkataan “1.364”; dan

(ii) dalam ruang *Jalan Kampung (km)*, dengan menggantikan perkataan “8.080” dengan perkataan “5.991”;

(b) berhubung dengan butiran Rimba Mas—

(i) dalam ruang *Jalan Masuk (km)*, dengan menggantikan perkataan “0.69” dengan perkataan “2.345”; dan

(ii) dalam ruang *Jalan Kampung (km)*, dengan menggantikan perkataan “6.26” dengan perkataan “5.110”; dan

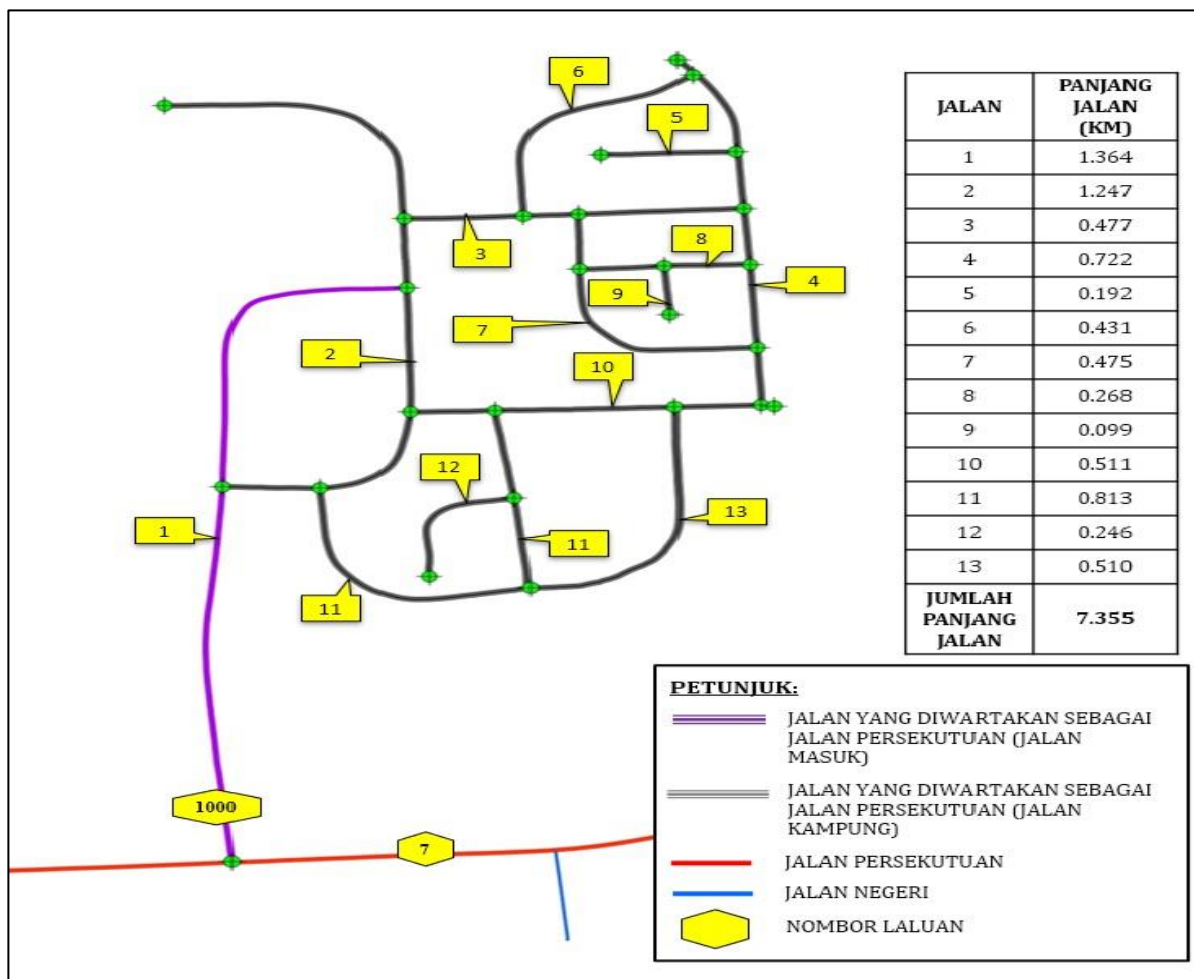
- (c) berhubung dengan butiran Chuping—
- (i) dalam ruang *Jalan Masuk (km)*, dengan menggantikan perkataan “6.354” dengan perkataan “6.376”; dan
- (ii) dalam ruang *Jalan Kampung (km)*, dengan menggantikan perkataan “25.640” dengan perkataan “13.839”.

**Pindaan Jadual Kedua**

3. Perintah ibu dipinda dalam Jadual Kedua—

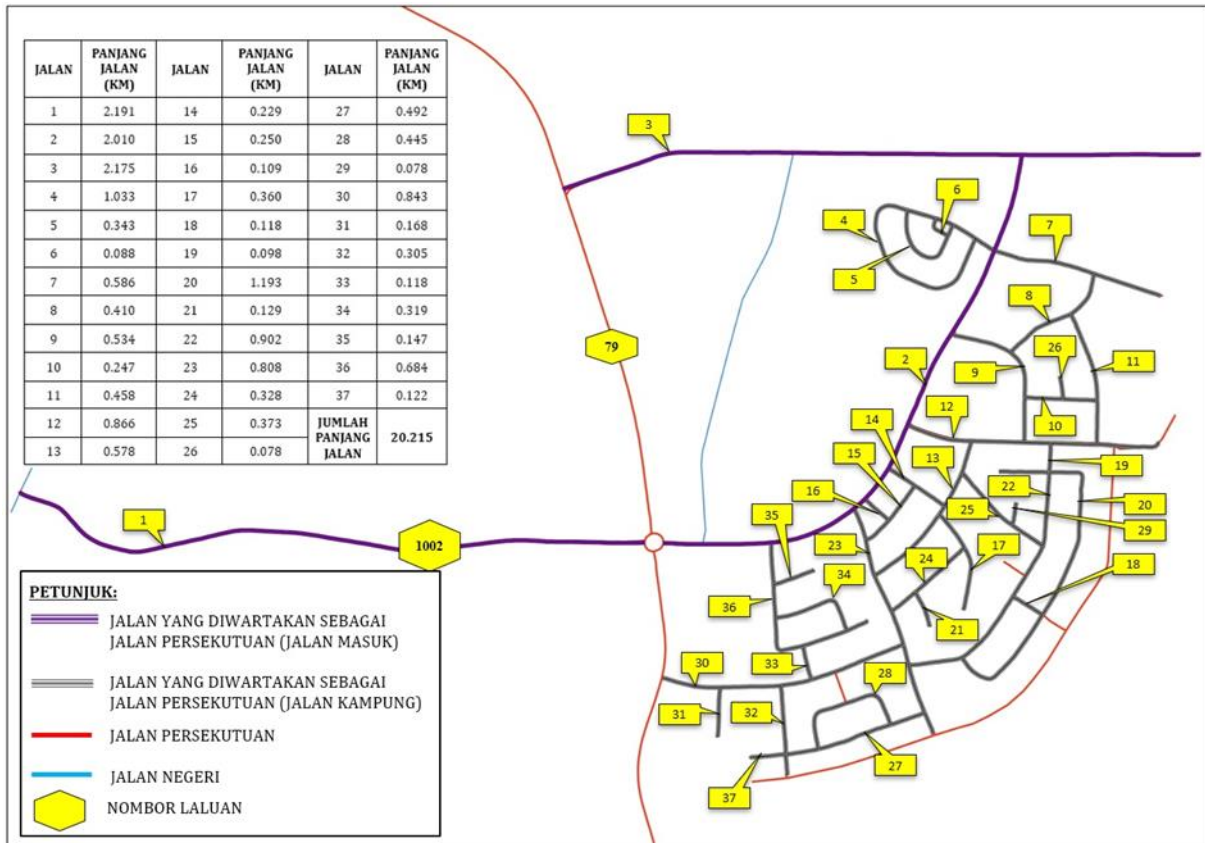
- (a) dengan menggantikan PETA 21: MATA AIR dengan peta yang berikut:

(b) dengan menggantikan PETA 22: CHUPING dengan peta yang berikut:

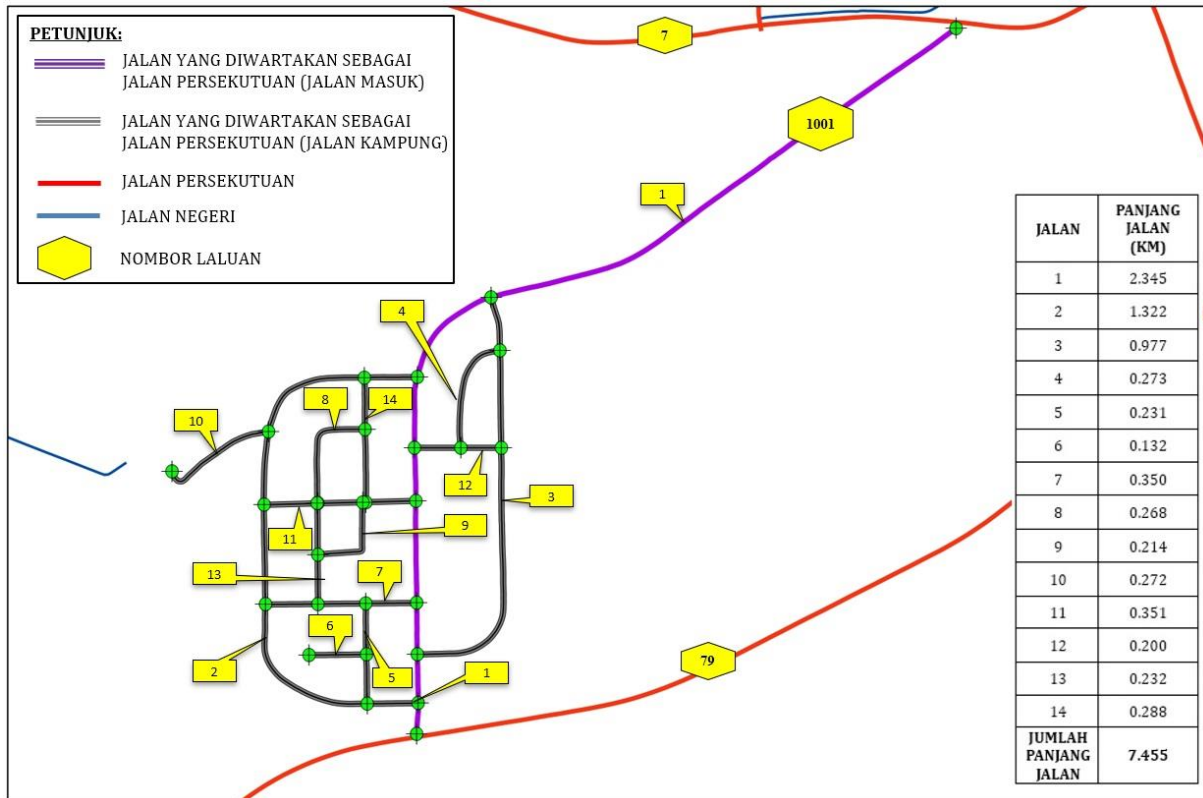

FEDERAL ROADS ACT 1959

FEDERAL ROADS (FELDA SCHEME) (AMENDMENT) (NO. 2) ORDER 2025

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Perlis, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Felda Scheme) (Amendment) (No. 2) Order 2025**.

(2) This Order comes into operation on 30 June 2025.

**Amendment of First Schedule**

2. The Federal Roads (Felda Scheme) Order 1991 [*P.U. (A) 449/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading of State of Perlis—

(a) in relation to item Mata Air—

(i) in column *Approach Roads (km)*, by substituting for the words “2.750” the words “1.364”; and

(ii) in column *Village Roads (km)*, by substituting for the words “8.080” the words “5.991”;

(b) in relation to item Rimba Mas—

(i) in column *Approach Roads (km)*, by substituting for the words “0.69” the words “2.345”; and

(ii) in column *Village Roads (km)*, by substituting for the words “6.26” the words “5.110”; and

(c) in relation to item Chuping—

(i) in column *Approach Roads (km)*, by substituting for the words “6.354” the words “6.376”; and

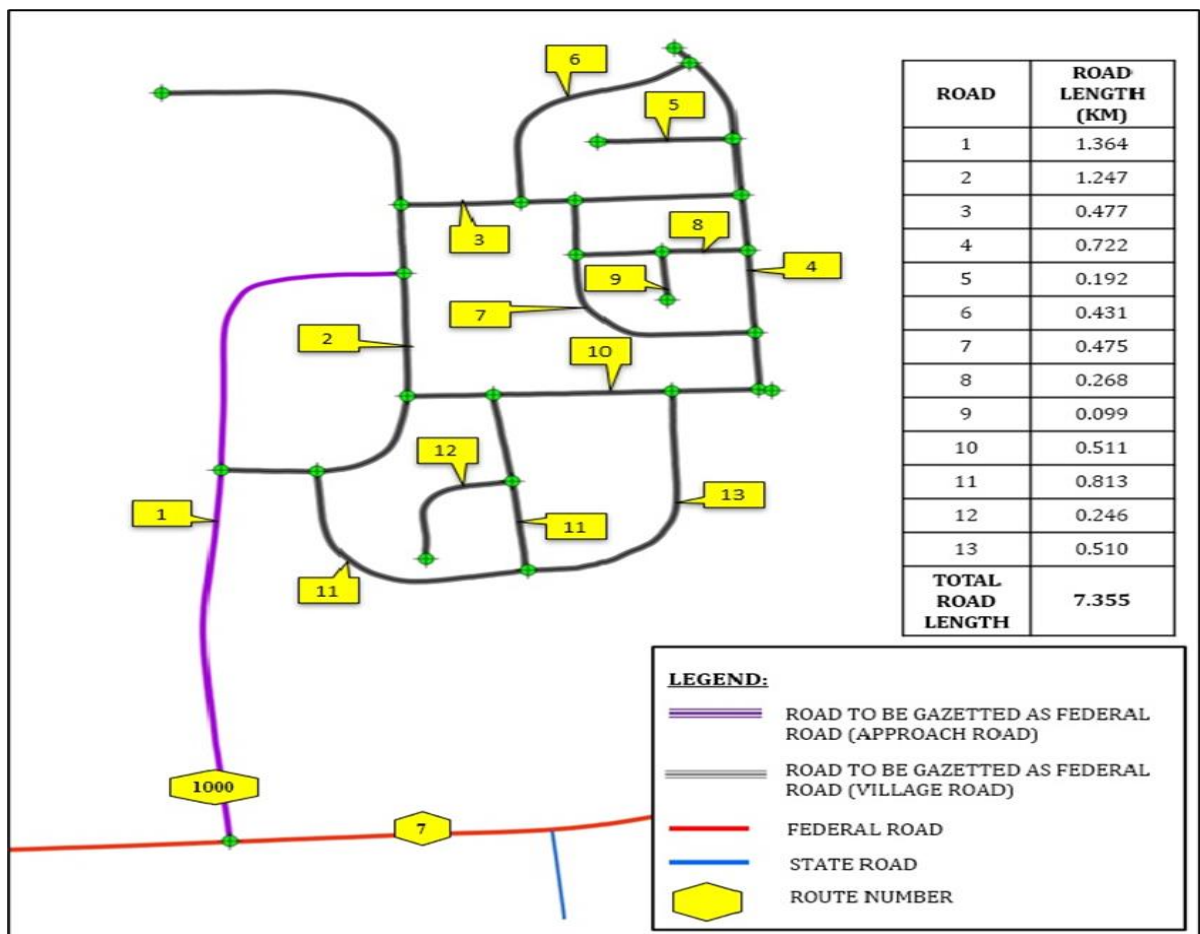
(ii) in column *Village Roads (km)*, by substituting for the words “25.640” the words “13.839”.

**Amendment of Second Schedule**

3. The principal Order is amended in the Second Schedule—

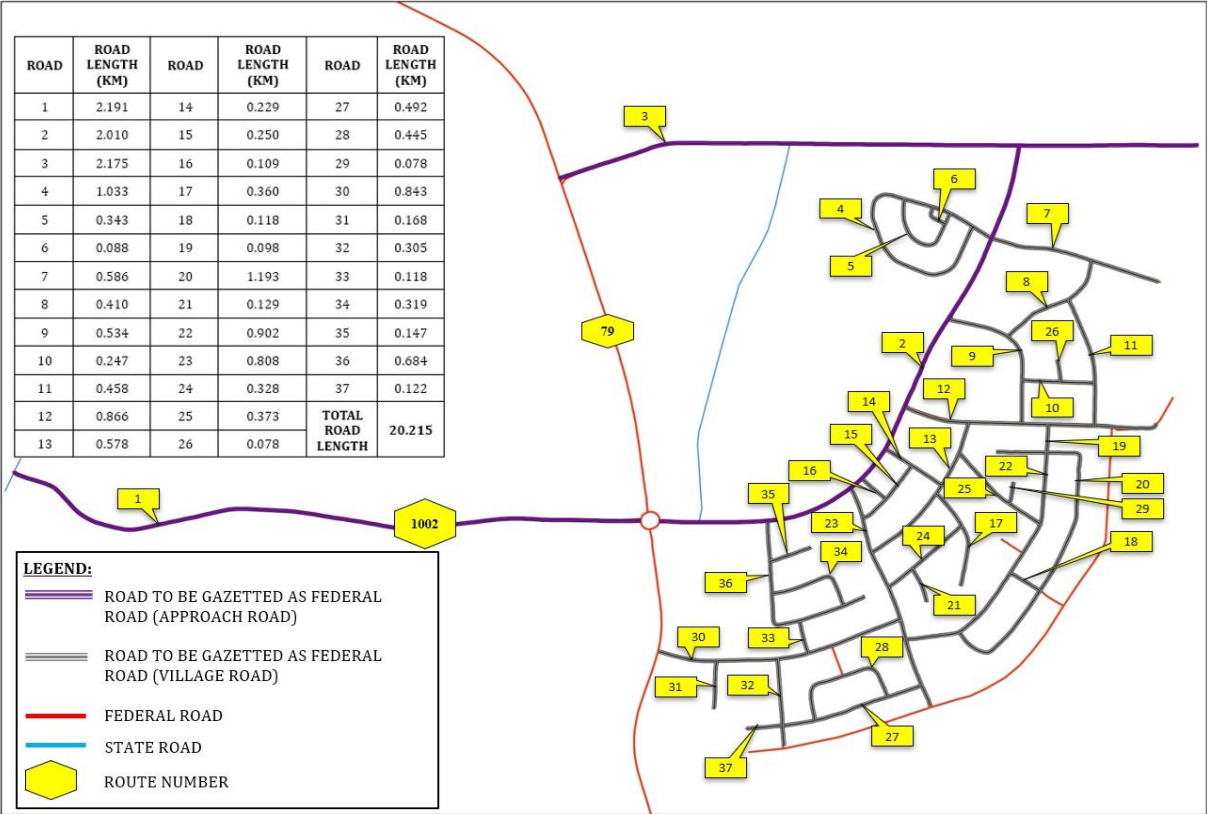
(a) by substituting for MAP 21: MATA AIR the following map:

(b) by substituting for MAP 22: CHUPING the following map:

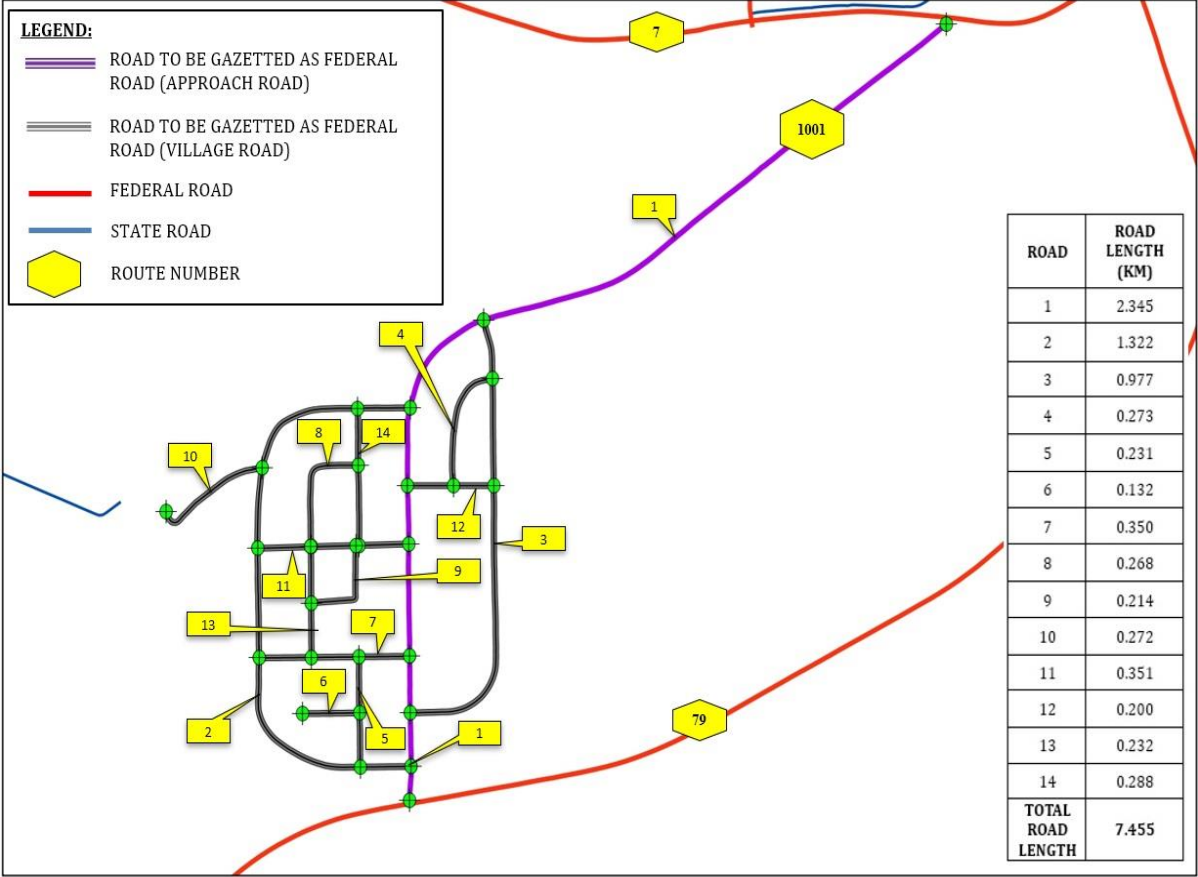
“MAP 22: CHUPING
