**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Kawalan Bekalan (Barang-Barang Kawalan) (No. 3) 2025**.

**Barang-barang kawalan**

2. Barang-barang yang dinyatakan dalam Jadual diisytiharkan sebagai barang-barang kawalan bagi tempoh mulai 27 Mei 2025 hingga 4 Jun 2025.

CONTROL OF SUPPLIES ACT 1961

CONTROL OF SUPPLIES (CONTROLLED ARTICLES) (NO. 3) ORDER 2025

IN exercise of the powers conferred by section 5 of the Control of Supplies Act 1961 [*Act 122*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Control of Supplies (Controlled Articles) (No. 3) Order 2025**.

**Controlled articles**

2. The articles specified in the Schedule are declared to be controlled articles for the period from 27 May 2025 to 4 June 2025.

SCHEDULE

CONTROLLED ARTICLES

1. Imported buffalo meat (India) (not including tenderloin)
2. Chicken wing
3. Imported round cabbage (Indonesia and China, not including Beijing cabbage)
4. Coconut milk
5. Live pig
6. Pork (belly)
7. Pork (lean and fat)
