IMMIGRATION AND PASSPORTS (BUKIT KAYU HITAM FREE TAX ZONE)  
(EXEMPTION) (REVOCATION) ORDER 2025

IN exercise of the powers conferred by section 55 of the Immigration Act 1959/63 [*Act 155*] and section 4 of the Passports Act 1966 [*Act 150*], the Minister makes the following order:

**Citation**

1. This order may be cited as the **Immigration and Passports (Bukit Kayu Hitam Free Tax Zone) (Exemption) (Revocation) Order 2025**.
