(PENEPIAN FI KEPADA MURID BERKEPERLUAN KHAS) 2025

PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Murid Berkeperluan Khas) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 14 April 2025.

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam butiran 1(a)(i) Jadual Kedua kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2016 [*P.U. (A) 86/2016*] diketepikan berkenaan dengan seseorang yang berdaftar sebagai murid berkeperluan khas dengan Bahagian Pendidikan Teknik dan Vokasional, Kementerian Pendidikan Malaysia.

(2) Penepian fi di bawah subperaturan (1) terpakai bagi permohonan pengiktirafan kemahiran yang dibuat dalam tempoh tiga tahun dari 14 April 2025 hingga 13 April 2028.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT
(WAIVER OF FEE TO STUDENT WITH SPECIAL NEEDS) REGULATIONS 2025

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Student with Special Needs) Regulations 2025**.

(2) These Regulations come into operation on 14 April 2025.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in item 1(a)(i) of the Second Schedule to the National Skills Development (Fees and Charges) Regulations 2016 [P.U. (A) 86/2016] is waived in respect of any person who registers as a student with special needs with the Technical and Vocational Education Division, the Ministry of Education of Malaysia.

(2) The waiver of fee under subregulation (1) applies to the application for the recognition of skills made within the period of three years from 14 April 2025 to 13 April 2028.
