ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (TEMPORARY CESSATION) (NO. 2) ORDER 2025

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **National Speed Limit (Temporary Cessation) (No. 2) Order 2025**.

(2) This Order has effect from 28 March 2025 to 6 April 2025.

Temporary cessation

2. Subparagraph 2(1) of the National Speed Limit Order 1989 [P.U. (A) 18/1989] shall cease to have effect.
