AKTA INDUSTRI PERKHIDMATAN AIR 2006

PERATURAN-PERATURAN INDUSTRI PERKHIDMATAN AIR
(PENGKOMPANAN KESALAHAN) (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 163(1) dan perenggan 179(g) Akta Industri Perkhidmatan Air 2006 [*Akta 655*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Industri Perkhidmatan Air (Pengkompanaan Kesalahan) (Pindaan) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Februari 2025.

Pindaan Jadual Pertama

2. Peraturan-Peraturan Industri Perkhidmatan Air (Pengkompanaan Kesalahan) 2008 [*P.U. (A) 259/2008*] dipinda dalam Jadual Pertama dengan memasukkan selepas butiran (c) dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:

“(d) Kesalahan yang dilakukan di bawah subkaedah 7(2) Kaedah-Kaedah Industri Perkhidmatan Air (Permit) 2007 [*P.U. (A) 438/2007*]

(e) Kesalahan yang dilakukan di bawah subperaturan 5(2) Peraturan-Peraturan Industri Perkhidmatan Air (Perkhidmatan Nyahenap Cemar) 2021 [*P.U. (A) 140/2021*]”.

WATER SERVICES INDUSTRY ACT 2006

WATER SERVICES INDUSTRY (COMPOUNDING OF OFFENCES)
(AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by subsection 163(1) and paragraph 179(g) of the Water Services Industry Act 2006 [Act 655], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Water Services Industry (Compounding of Offences) (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 1 February 2025.

Amendment of First Schedule

2. The Water Services Industry (Compounding of Offences) Regulations 2008 [P.U. (A) 259/2008] are amended in the First Schedule by inserting after item (c) and the particulars relating to it the following item and particulars:

“(d) The offence committed under subrule 7(2) of the Water Services Industry (Permit) Rules 2007 [P.U. (A) 438/2007]

(e) The offence committed under subregulation 5(2) of the Water Services Industry (Desludging Services) Regulations 2021 [P.U. (A) 140/2021]”.
