PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 2) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 2) 2025**.

(2) Perintah ini mula berkuat kuasa pada 3 Februari 2025.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala Negeri Pahang Darul Makmur—

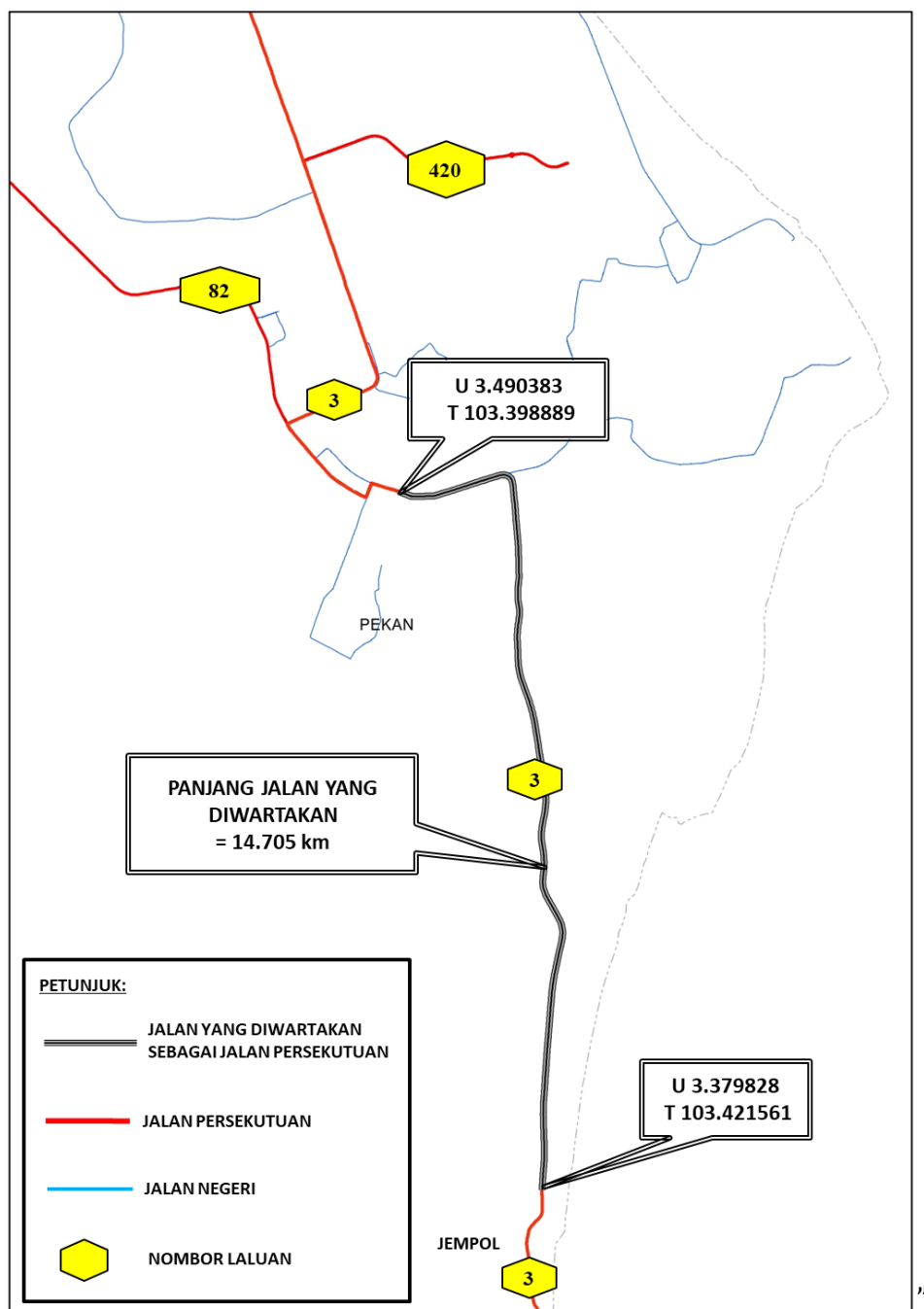
(a) dengan memasukkan selepas butiran 54 butiran yang berikut:

“55. (*Laluan 3*): *Jalan Al-Sultan Abdullah*

Bermula dari Agro Bazar Pekan di koordinat U 3.379828, T 103.421561 dan berakhir di Jambatan Sg. Air Hitam di koordinat U 3.490383, T 103.398889 termasuk jalan sambungannya di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 37: JALAN AL-SULTAN ABDULLAH (jarak sepanjang 14.705 km).”; dan

(b) dengan memasukkan selepas PETA 36: JALAN UTAMA PALONG peta yang berikut:

“PETA 37: JALAN AL-SULTAN ABDULLAH

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 2) ORDER 2025

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 2) Order 2025**.

(2) This Order comes into operation on 3 February 2025.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule under the heading of Negeri Pahang Darul Makmur—

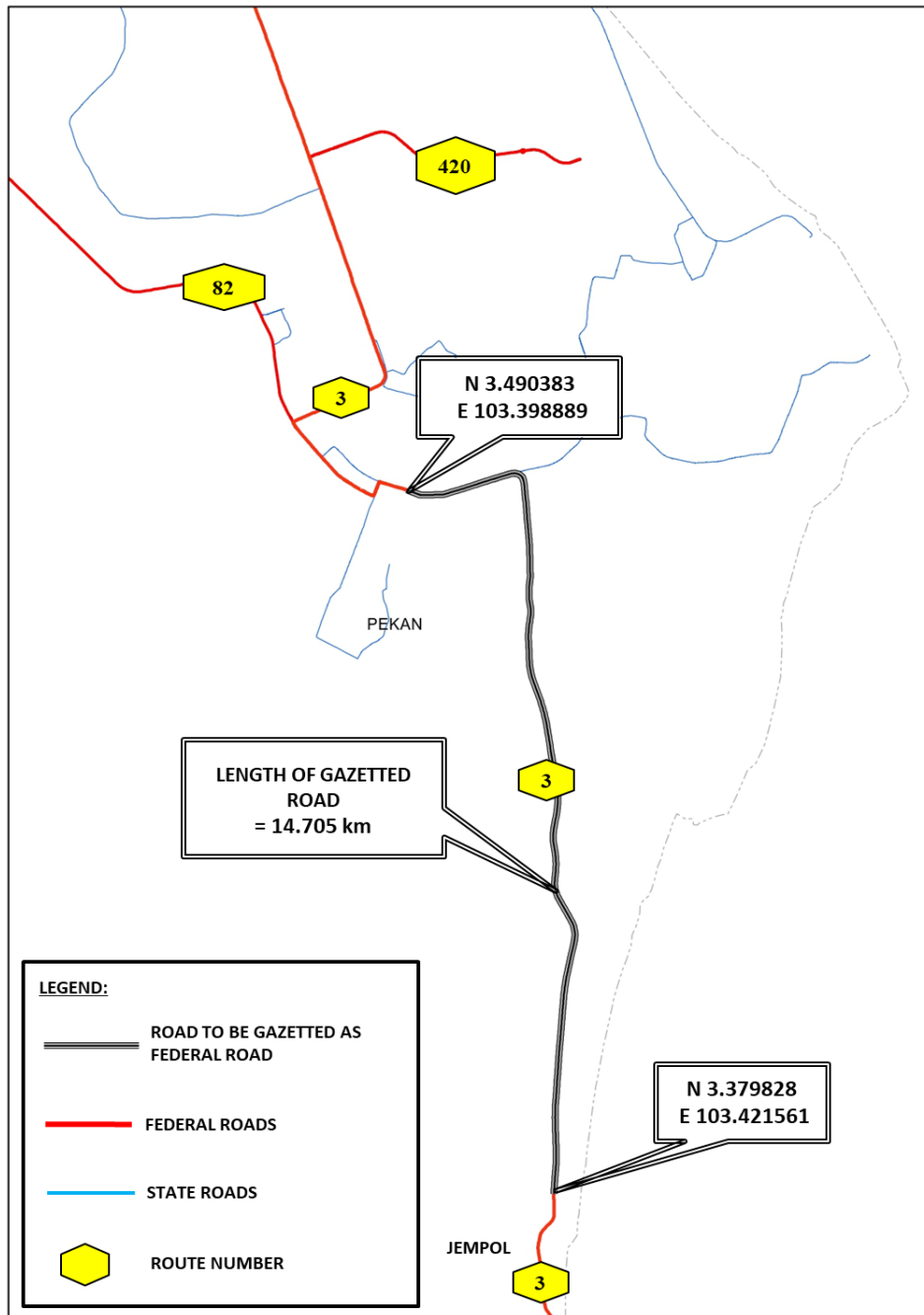
(a) by inserting after item 54 the following item:

“55. (*Route 3*): *Al-Sultan Abdullah Road*

Starting from Agro Bazar Pekan at coordinates N 3.379828, E 103.421561 and ending at Sg. Air Hitam Bridge at coordinates N 3.490383, E 103.398889 including its link road within the boundaries of right of way as shown on MAP 37: AL-SULTAN ABDULLAH ROAD (a distance of 14.705 km).”; and

(b) by inserting after MAP 36: PALONG MAIN ROAD the following map:
