PERINTAH HAD LAJU KEBANGSAAN (PEMBERHENTIAN SEMENTARA) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(1) Akta Pengangkutan Jalan 1987 [*Akta 333*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Had Laju Kebangsaan (Pemberhentian Sementara) 2025**.

(2) Perintah ini berkuat kuasa mulai 28 Januari 2025 hingga 2 Februari 2025.

**Pemberhentian sementara**

2. Subperenggan 2(1) Perintah Had Laju Kebangsaan 1989 [*P.U. (A) 18/1989*] hendaklah terhenti berkuat kuasa.

ROAD TRANSPORT ACT 1987

NATIONAL SPEED LIMIT (TEMPORARY CESSATION) ORDER 2025

IN exercise of the powers conferred by subsection 69(1) of the Road Transport Act 1987 [Act 333], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **National Speed Limit (Temporary Cessation) Order 2025**.

(2) This Order has effect from 28 January 2025 to 2 February 2025.

**Temporary cessation**

2. Subparagraph 2(1) of the National Speed Limit Order 1989 [P.U. (A) 18/1989] shall cease to have effect.
