AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan (Pindaan) 2025**.

(2) Subperenggan 2(*a*) dan (*c*) disifatkan telah mula berkuat kuasa pada 1 Oktober 2024.

(3) Subperenggan 2(*b*) disifatkan telah mula berkuat kuasa pada 22 April 2024.

(4) Subperenggan 2(*d*) disifatkan telah mula berkuat kuasa pada 11 September 2024.

Pindaan Jadual

2. Perintah Menteri-Menteri Kerajaan Persekutuan 2023 [*P.U. (A) 27/2023*] dipinda dalam Jadual—

(*a*) berkenaan dengan Kementerian Kewangan, dengan memasukkan selepas butiran “Agensi Pelaksanaan Ekonomi dan Koordinasi Strategik Nasional (LAKSANA)” dalam ruang “Jabatan/Perkara” butiran “Malaysia Venture Capital Management Berhad (MAVCAP)”;

(*b*) berkenaan dengan Kementerian Perladangan dan Komoditi, dengan menggantikan butiran “Majlis Pensijilan Minyak Sawit Malaysia (MPOCC)” dalam ruang “Jabatan/Perkara” dengan butiran “Minyak Sawit Mampan Malaysia (MSPO)”;

- (c) berkenaan dengan Kementerian Sains, Teknologi dan Inovasi, dengan memotong butiran “Malaysia Venture Capital Management Berhad (MAVCAP)” dalam ruang “Jabatan/Perkara”; dan
- (d) berkenaan dengan Kementerian Peralihan Tenaga dan Transformasi Air, dengan menggantikan butiran “Bahagian Bekalan Air (BBA)” dalam ruang “Jabatan/Perkara” dengan butiran “Jabatan Bekalan Air”.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Ministers of the Federal Government (Amendment) Order 2025**.

(2) Subparagraphs 2(a) and (c) are deemed to have come into operation on 1 October 2024.

(3) Subparagraph 2(b) is deemed to have come into operation on 22 April 2024.

(4) Subparagraph 2(d) is deemed to have come into operation on 11 September 2024.

Amendment of Schedule

2. The Ministers of the Federal Government Order 2023 [P.U. (A) 27/2023] is amended in the Schedule—

(a) in respect of the Ministry of Finance, by inserting after the item “Agensi Pelaksanaan Ekonomi dan Koordinasi Strategik Nasional (LAKSANA)” in the “Department/Subject” column the item “Malaysia Venture Capital Management Berhad (MAVCAP)”;

(b) in respect of the Ministry of Plantation and Commodities, by substituting for the item “Malaysian Palm Oil Certification Council (MPOCC)” in the “Department/Subject” column the item “Malaysian Sustainable Palm Oil (MSPO)”;

- (c) in respect of the Ministry of Science, Technology and Innovation, by deleting the item “Malaysia Venture Capital Management Berhad (MAVCAP)” in the “Department/Subject” column; and

- (d) in respect of the Ministry of Energy Transition and Water Transformation, by substituting for the item “Water Supply Division (BBA)” in the “Department/Subject” column the item “Water Supply Department”.
