PERATURAN-PERATURAN KOPERASI
(MAJLIS PERUNDINGAN KOPERASI KEBANGSAAN) (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh perenggan 86(2)(m) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Koperasi (Majlis Perundingan Koperasi Kebangsaan) (Pindaan) 2025**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 17 Januari 2025.

2. Peraturan-Peraturan Koperasi (Majlis Perundingan Koperasi Kebangsaan) 2010 [*P.U. (A) 130/2010*] dipinda dalam subperaturan 5(1)—

(a) dalam perenggan (e), dengan memotong perkataan “Eksekutif”; dan

(b) dengan memasukkan selepas perenggan (e) perenggan yang berikut:

“(ea) Ketua Pegawai Eksekutif Suruhanjaya Koperasi Malaysia atau wakilnya;”.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (THE NATIONAL CO-OPERATIVE
CONSULTATIVE COUNCIL) (AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by paragraph 86(2)(m) of the Co-operative Societies Act 1993 [Act 502], the Commission, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Co-operative Societies (The National Co-operative Consultative Council) (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 17 January 2025.

Amendment of regulation 5

2. The Co-operative Societies (The National Co-operative Consultative Council) Regulations 2010 [*P.U. (A) 130/2010*] are amended in subregulation 5(1)—

(a) in paragraph (e), by deleting the word “Executive”; and

(b) by inserting after paragraph (e) the following paragraph:

“(ea) the Chief Executive Officer of the Malaysian Co-operative Societies Commission or his representative;”.
