REGISTRATION OF PHARMACISTS ACT 1951

REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE) ORDER 2025

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [*Act 371*], the Minister, after consulting the Board, makes the following order:

**Citation**

1. This order may be cited as the **Registration of Pharmacists (Amendment of First Schedule) Order 2025**.

**Amendment of First Schedule**

2. The Registration of Pharmacists Act 1951 is amended in the First Schedule—

(a) in relation to the country of “Malaysia”—

(i) in the item “Universiti Kebangsaan Malaysia” by inserting after the existing particulars the following particulars:

*Description of qualification*

“Sarjana Muda Farmasi dengan  
Kepujian/*Bachelor of Pharmacy with  
Honours*  
(Recognised on 8 September 2022)”;  
and

(ii) in the item “Universiti Teknologi MARA” by inserting after the existing particulars the following particulars:

*Description of qualification*

“Sarjana Muda Farmasi dengan  
Kepujian/*Bachelor of Pharmacy with  
Honours*  
(Recognised on 31 October 2023)”.

(b) by inserting after the country of “United Arab Emirates” the following country:

“ Jordan	Zarqa University	Bachelor of Pharmacy (Recognised on 14 May 2024)”.
