PADA menjalankan kuasa yang diberikan oleh seksyen 72 Akta Keselamatan Sosial Pekerja 1969 [Akta 4], Menteri membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Keselamatan Sosial Pekerja (Perbekalan) (No. 2) 2024**.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (SUPPLY) (NO. 2) REGULATIONS 2024

IN exercise of the powers conferred by section 72 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following regulations:

Citation

1. These regulations may be cited as the **Employees' Social Security (Supply) (No. 2) Regulations 2024**.

Issue for expenditure for the year 2025

2. The issue of a sum not exceeding one billion six hundred forty million ninety six thousand ringgit (RM1,640,096,000) from the Social Security Fund for the expenditure on administration of the Social Security Scheme for the year 2025 is hereby authorized for the purposes specified in the Schedule.
