PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Setiawangsa-Pantai) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

“7. Semua kenderaan yang dimiliki oleh Lembaga Lebuhraya Malaysia.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(SETIAWANGSA-PANTAI EXPRESSWAY) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Setiawangsa-Pantai Expressway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

**Amendment of Third Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Setiawangsa-Pantai Expressway) Order 2022 [*P.U. (A) 38/2022*] is amended in the Third Schedule by inserting after item 6 the following item:

“7. All vehicles belonging to the Highway Authority Malaysia.”.
