PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Pulau Pinang) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Pulau Pinang) 1995 [*P.U. (A) 410/1995*] dipinda dalam Jadual Keempat dengan memasukkan selepas butiran 6 butiran yang berikut:

“7. Semua kenderaan yang dimiliki oleh Lembaga Lebuhraya Malaysia.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(PENANG BRIDGE) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Penang Bridge) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

**Amendment of Fourth Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Penang Bridge) Order 1995 [*P.U. (A) 410/1995*] is amended in the Fourth Schedule by inserting after item 6 the following item:

“7. All vehicles belonging to the Highway Authority Malaysia.”.
