**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Duta-Ulu Kelang) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

“8. Semua kenderaan yang dimiliki oleh Lembaga Lebuhraya Malaysia.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(DUTA-ULU KELANG EXPRESSWAY) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister make the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Duta-Ulu Kelang Expressway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

**Amendment of Third Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Duta-Ulu Kelang Expressway) Order 2009 [*P.U. (A) 51/2009*] is amended in the Third Schedule by inserting after item 7 the following item:

“8. All vehicles belonging to the Highway Authority Malaysia.”.
