Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Skim Penyuraian Trafik Kuala Lumpur Barat-Hubungan Kerinchi dan Hubungan Damansara) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(WESTERN KUALA LUMPUR TRAFFIC DISPERSAL SCHEME HIGHWAY-KERINCHI LINK
AND DAMANSARA LINK) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway-Kerinchi Link and Damansara Link) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

Amendment of Fifth Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Western Kuala Lumpur Traffic Dispersal Scheme Highway-Kerinchi Link and Damansara Link) Order 2001 [*P.U. (A) 274/2001*] is amended in the Fifth Schedule by inserting after item 5 the following item:

“6. All vehicles belonging to the Highway Authority Malaysia.”.
