PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Maju Expressway) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Maju Expressway) 2016 [*P.U. (A) 3/2016*] dipinda dalam Jadual Ketiga dengan memasukkan selepas butiran 6 butiran yang berikut:

“7. Semua kenderaan yang dimiliki oleh Lembaga Lebuhraya Malaysia.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(MAJU EXPRESSWAY HIGHWAY) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Maju Expressway Highway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

**Amendment of Third Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Maju Expressway Highway) Order 2016 [*P.U. (A) 3/2016*] is amended in the Third Schedule by inserting after item 6 the following item:

“7. All vehicles belonging to the Highway Authority Malaysia.”.
