PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuh Raya Bertingkat Sungai Besi-Ulu Kelang) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(SUNGAI BESI-ULU KELANG ELEVATED EXPRESSWAY) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Sungai Besi-Ulu Kelang Elevated Expressway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

Amendment of Third Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Sungai Besi-Ulu Kelang Elevated Expressway) Order 2022 [*P.U. (A) 333/2022*] is amended in the Third Schedule by inserting after item 6 the following item:

“7. All vehicles belonging to the Highway Authority Malaysia.”.
