PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Cheras-Kajang) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Cheras-Kajang) 1999 [*P.U. (A) 15/1999*] dipinda dalam Jadual Ketiga dengan memasukkan selepas butiran 5 butiran yang berikut:

“6. Semua kenderaan yang dimiliki oleh Lembaga Lebuhraya Malaysia.”.

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(CHERAS-KAJANG HIGHWAY) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Akta 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Cheras-Kajang Highway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

Amendment of Third Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Cheras-Kajang Highway) Order 1999 [*P.U. (A) 15/1999*] is amended in the Third Schedule by inserting after item 5 the following item:

“6. All vehicles belonging to the Highway Authority Malaysia.”.
