**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Lebuhraya Utara Selatan Hubungan Tengah dan Lebuhraya KLIA) (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2025.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(NORTH SOUTH EXPRESSWAY CENTRAL LINK AND KLIA EXPRESSWAY)  
(AMENDMENT) ORDER 2024

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 January 2025.

**Amendment of Thirteenth Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (North South Expressway Central Link and KLIA Expressway) Order 2002 [*P.U. (A) 437/2002*] is amended in the Thirteenth Schedule by inserting after item 6 the following item:

“7. All vehicles belonging to the Highway Authority Malaysia.”.
