AKTA JALAN PERSEKUTUAN 1959

PERINTAH JALAN PERSEKUTUAN (SARAWAK) (PINDAAN) (NO. 8) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Sarawak) (Pindaan) (No. 8) 2024**.

(2) Perintah ini mula berkuat kuasa pada 24 Disember 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Sarawak) 1996 [P.U. (A) 551/1996], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dalam Jadual Pertama di bawah kepala LEBUH RAYA PAN BORNEO, dengan memasukkan selepas butiran (jp) butiran yang berikut:

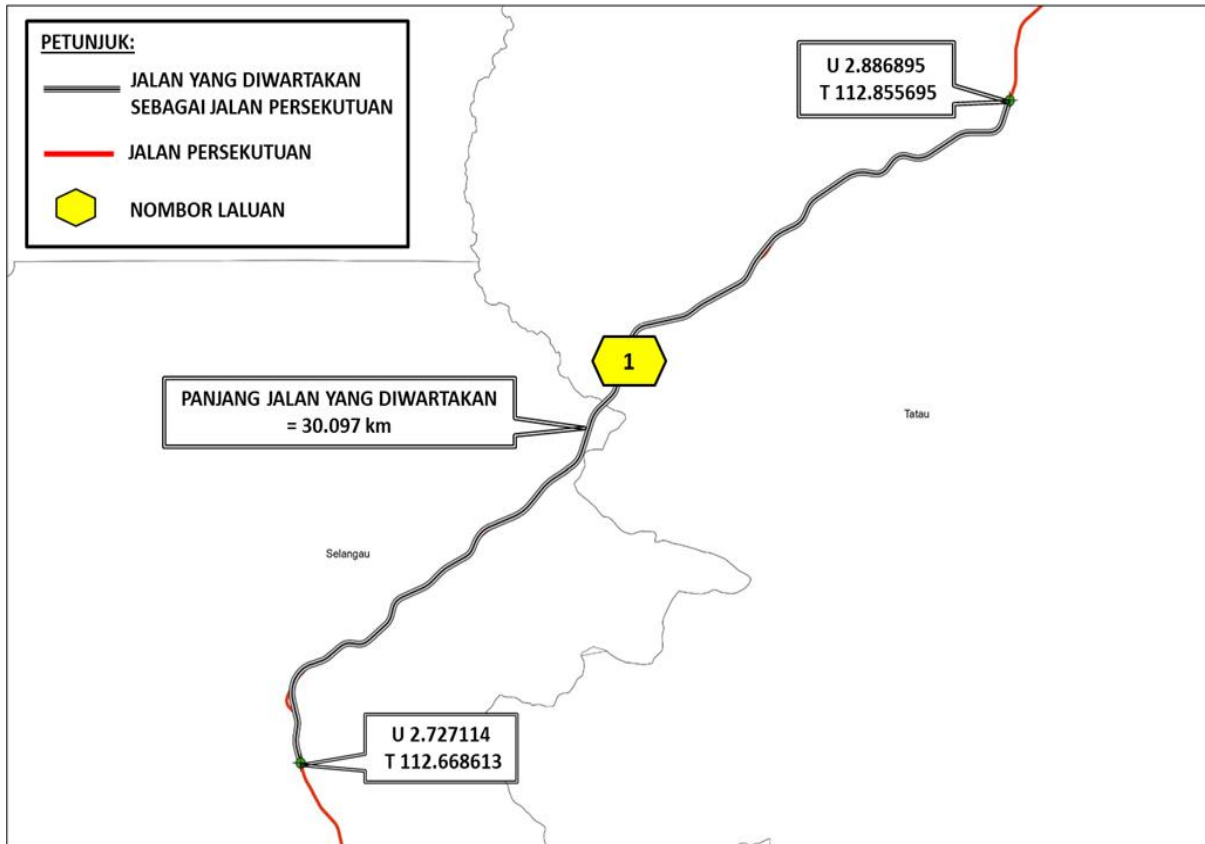
"(jq) (Laluan 1): Jambatan Sungai Arip-Pekan Tatau

Bermula di koordinat U 2.727114, T 112.668613 dan berakhir di koordinat U 2.886895, T 112.855695 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA JAMBATAN SUNGAI ARIP-PEKAN TATAU (jarak sepanjang 30.097 km).".

Pindaan Jadual Ketiga

3. Perintah ibu dipinda dalam Jadual Ketiga dengan memasukkan selepas PETA SIMPANG PANTU-JAMBATAN SUNGAI ENTULANG peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (SARAWAK) (AMENDMENT) (NO. 8) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Sarawak) (Amendment) (No. 8) Order 2024**.

(2) This Order comes into operation on 24 December 2024.

Amendment of First Schedule

2. The Federal Roads (Sarawak) Order 1996 [*P.U. (A) 551/1991*], which is referred to as the “principal Order” in this Order, is amended in the First Schedule under the heading of PAN BORNEO HIGHWAY, by inserting after item (*jp*) the following item:

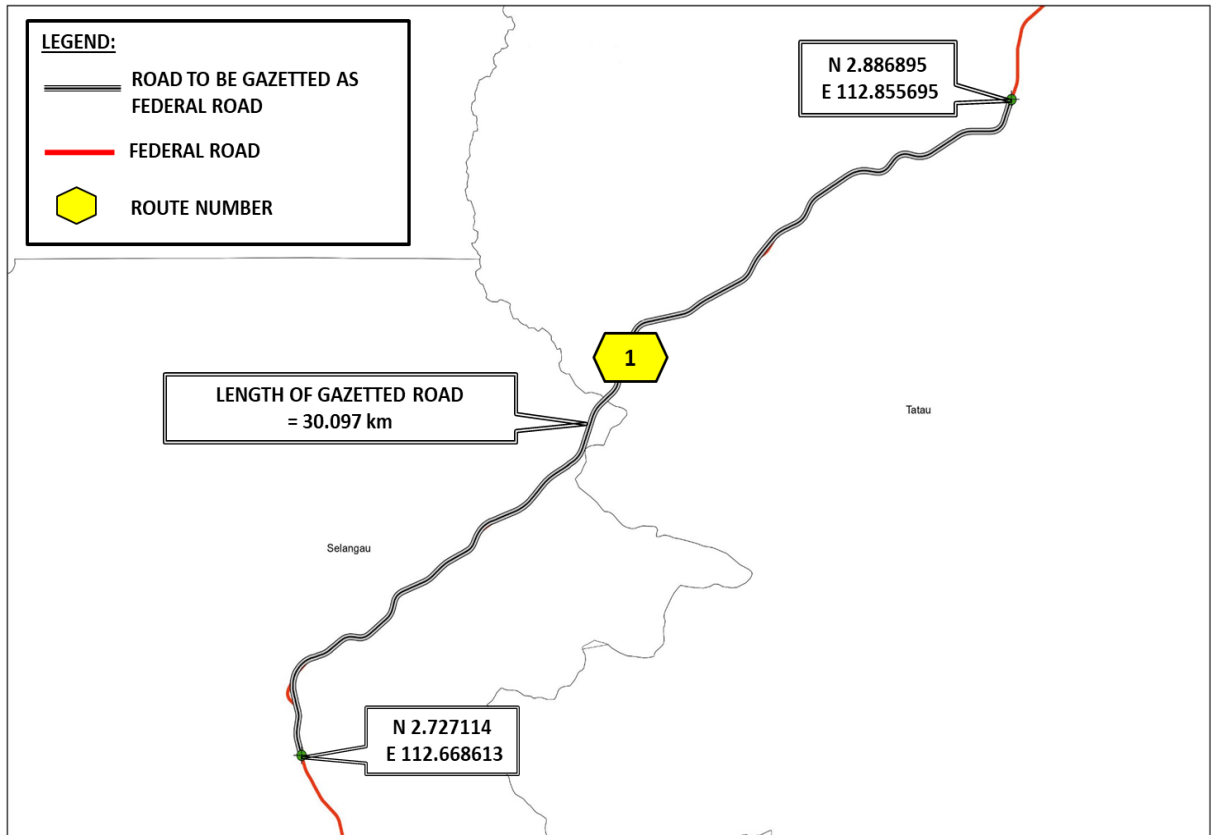
“(jq) (Route 1): Sungai Arip Bridge-Tatau Town

Starting at coordinates N 2.727114, E 112.668613 and ending at coordinates N 2.886895, E 112.855695 including its link road within the boundaries of right of way as shown on MAP OF SUNGAI ARIP BRIDGE-TATAU TOWN (a distance of 30.097 km).”.

Amendment of Third Schedule

3. The principal Order is amended in the Third Schedule by inserting after MAP OF PANTU JUNCTION-SUNGAI ENTULANG BRIDGE the following map:
