PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 15) 2024

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Johor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 15) 2024**.

(2) Perintah ini mula berkuat kuasa pada 29 November 2024.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala Negeri Johor Darul Takzim—

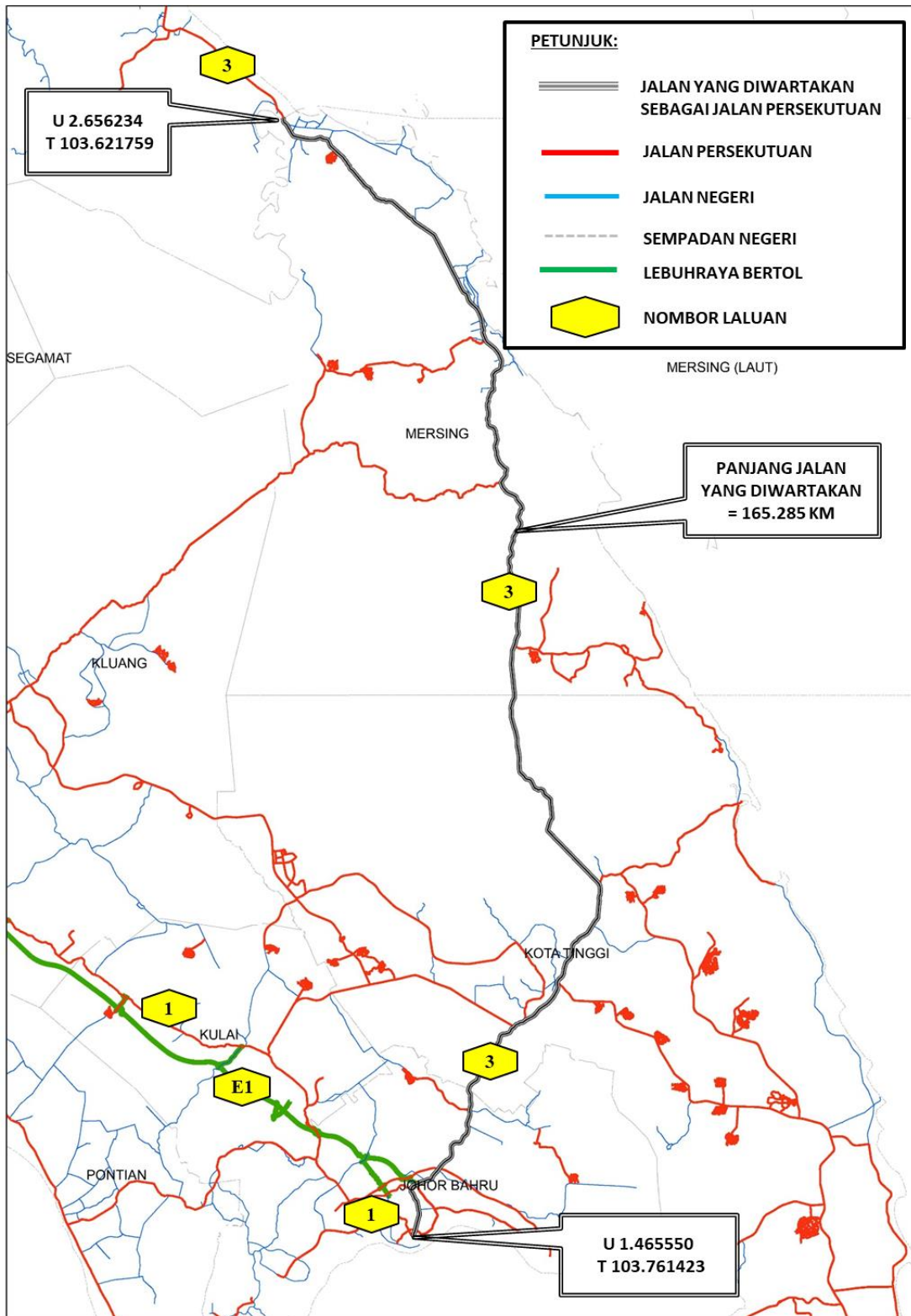
(a) dengan menggantikan butiran 3 dengan butiran yang berikut:

“3. *(Laluan 3): Jalan Johor Bahru-Endau*

Bermula dari Johor Bahru di koordinat U 1.465550, T 103.761423 dan berakhir di sempadan negeri Johor dan Pahang di koordinat U 2.656234, T 103.621759 termasuk jalan sambungannya di dalam sempadan hak lalu lalang sebagaimana yang ditunjukkan dalam PETA 14: JALAN JOHOR BAHRU-ENDAU (jarak sepanjang 165.285 km).”; dan

(b) dengan menggantikan PETA 14: JALAN JOHOR BAHRU-ENDAU dengan peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 15) ORDER 2024

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Johore, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 15) Order 2024**.

(2) This Order comes into operation on 29 November 2024.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading of Negeri Johor Darul Takzim—

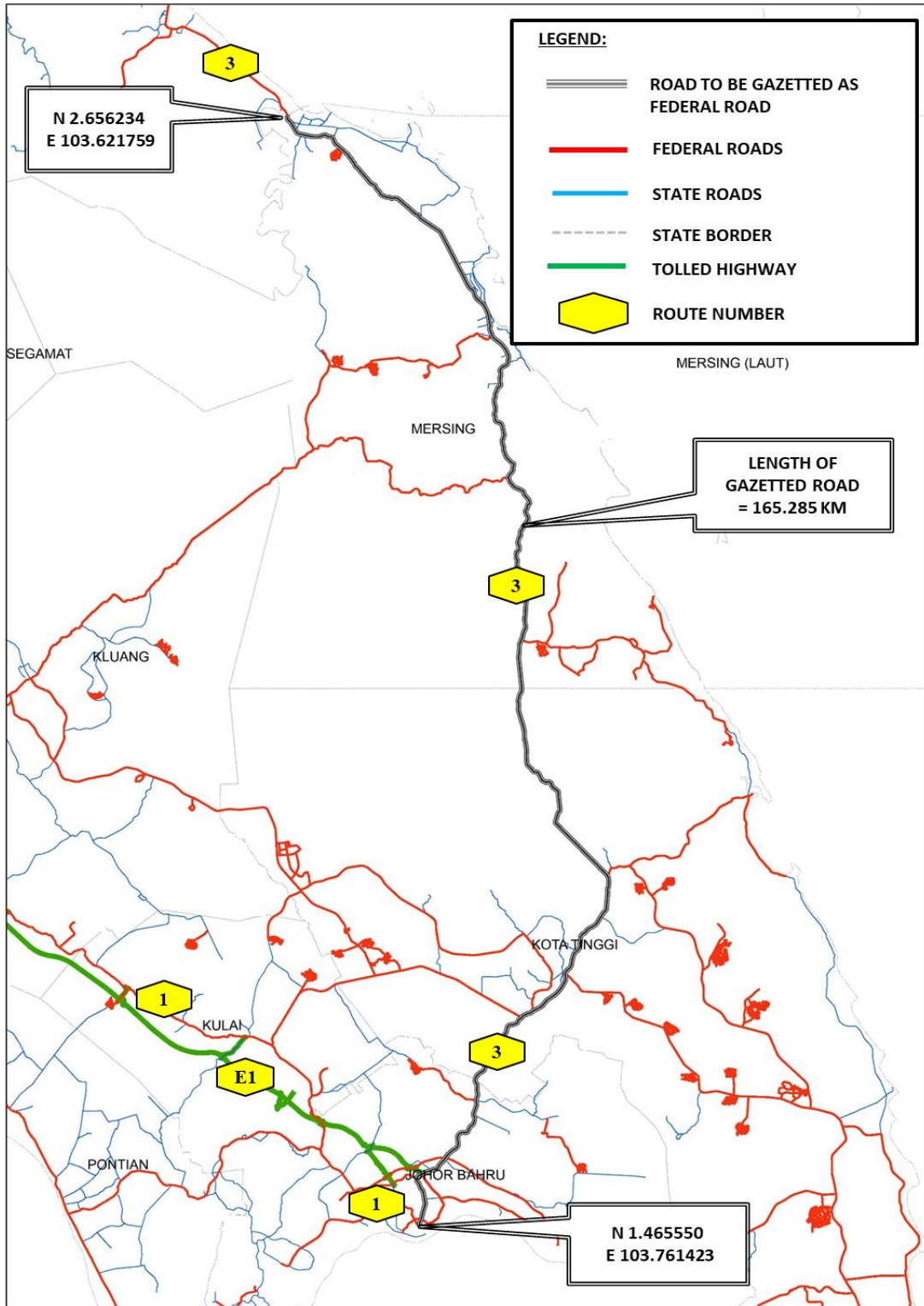
(a) by substituting for item 3 the following item:

“3. *(Route 3): Johor Bahru-Endau Road*

Starting from Johor Bahru at coordinates N 1.465550, E 103.761423 and ending at Johore and Pahang state boundary at coordinates N 2.656234, E 103.621759 including its link road within the boundaries of right of way as shown on MAP 14: JOHOR BAHRU-ENDAU ROAD (a distance of 165.285 km).”;
and

(b) by substituting for MAP 14: JOHOR BAHRU-ENDAU ROAD the following map:
