PERATURAN-PERATURAN KASTAM (PENGGOMPAUNAN KESALAHAN) (PINDAAN) 2024

PADA menjalankan kuasa yang diberikan oleh subseksyen 131(1) Akta Kastam 1967 [Akta 235], Menteri, dengan kelulusan Pendakwa Raya, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pengkompunan Kesalahan) (Pindaan) 2024**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Disember 2024.

2. Peraturan-Peraturan Kastam (Pengkompunan Kesalahan) 2020 [P.U. (A) 83/2020] dipinda dalam Jadual Pertama—

(a) dalam perenggan (a), dengan memasukkan selepas perkataan “seksyen 135C” perkataan “subseksyen 163Y(3)”; dan

(b) dalam perenggan (b), dengan memasukkan selepas perkataan “subperaturan 44(3)” perkataan “subperaturan 45A(6)”.

CUSTOMS ACT 1967

CUSTOMS (COMPOUNDING OF OFFENCES) (AMENDMENT) REGULATIONS 2024

IN exercise of the powers conferred by subsection 131(1) of the Customs Act 1967 [Act 235], the Minister, with the approval of the Public Prosecutor, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Compounding of Offences) (Amendment) Regulations 2024**.

(2) These Regulations come into operation on 1 December 2024.

Amendment of First Schedule

2. The Customs (Compounding of Offences) Regulations 2020 [P.U. (A) 83/2020] are amended in the First Schedule—

(a) in paragraph (a), by inserting after the words “section 135C” the words “subsection 163Y(3)”; and

(b) in paragraph (b), by inserting after the words “subregulation 44(3)” the words “subregulation 45A(6)”.
