PERATURAN-PERATURAN EKSAIS (PENGGOMPAUNAN KESALAHAN) (PINDAAN) 2024

PADA menjalankan kuasa yang diberikan oleh subseksyen 69(1) Akta Eksais 1976 [Akta 176], Menteri, dengan kelulusan Pendakwa Raya, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Eksais (Pengkompunan Kesalahan) (Pindaan) 2024**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Disember 2024.

2. Peraturan-Peraturan Eksais (Pengkompunan Kesalahan) 2020 [P.U. (A) 82/2020] dipinda dalam Jadual Pertama—

(a) dalam perenggan (a), dengan memasukkan selepas perkataan “seksyen 76” perkataan “subseksyen 91AB(3)”; dan

(b) dalam perenggan (b), dengan memasukkan selepas perkataan “peraturan 47” perkataan “subperaturan 47A(6)”.

EXCISE ACT 1976

EXCISE (COMPOUNDING OF OFFENCES) (AMENDMENT) REGULATIONS 2024

IN exercise of the powers conferred by subsection 69(1) of the Excise Act 1976 [Act 176], the Minister, with the approval of the Public Prosecutor, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Excise (Compounding of Offences) (Amendment) Regulations 2024**.

(2) These Regulations come into operation on 1 December 2024.

Amendment of First Schedule

2. The Excise (Compounding of Offences) Regulations 2020 [P.U. (A) 82/2020] are amended in the First Schedule—

(a) in paragraph (a), by inserting after the words “section 76” the words “subsection 91AB(3)”; and

(b) in paragraph (b), by inserting after the words “regulation 47” the words “subregulation 47A(6)”.
